- VI. BCAEO Update and Action Items Kris Schoenow
 - BCAEO conducted an RFP to select an interim provider for Kalamazoo County
 (Kalamazoo County CAA returned their designation). Community Action South Central
 was selected as the interim provider and will expand their service region to include
 Kalamazoo County. Existing staff will transition to Community Action South Central. A
 new office space will be available July 2019. A public hearing is scheduled for June 10,
 2019 to collect information on the transition progress.

- MOCAP has had many staff transitions over the past 18 months including the second executive director resigning in February 2019. BCAEO is working with MOCAP on their quality improvement plan. In February, MOCAP had a ransomware attack to their IT infrastructure and is having difficulty in retrieving data.
- GCCARD had a ransomware attack to their county's systems in April 2019. There data was restored a few days later.
- Kris Schoenow will present to CAA's about IT vulnerability, protecting data
