I. Welcome and introductions

- Chair Edwards-Sutton called the meeting to order at 10:05 am via conference call
- Absent: James Borchard, Kortni Campbell, Sonjalita Hulbert, Jacob Maas, LaTarro Traylor
- II. Approval of November 17, 2017 Meeting Minutes Chair Edwards-Sutton requested a motion to approve the minutes from the November 17, 2017 MCCAEO meeting. Fran Amos made the motion to approve the minutes; Marcella Wilson seconded the motion. The motion passed unanimously.
- III. BCAEO Update and Action Items Kris Schoenow
 - BCAEO Update/Accomplishments
 - o CSBG FY17 planning allocation (still planning allocation as there is not an approved federal budget) is \$25.8 million
 - o A Government shutdown would create some challenges but we have a structure in place to use remaining funds from prior year; also could give a 2 month advance to use during small government shutdown
 - o The State Plan due to federal partner by end of March
 - o Developing FY19 State Plan; staff and advisory group are meeting to begin working on it; planning amount will be used
 - o Implementing new federal requirements
 - new ROMA Next Generation; revised national performance indicators
 - 2 categories (services and outcomes) to show impact of work
 - o Community Action Agencies are a very collaborative body; will have opportunity for community initiatives through tracking their work
 - Provided agencies training with assistance from Michigan Community Action
 - o Improved statewide database to collect data
 - CSBG training at Mid Michigan Community Action Agency had 14 CAA's attend
 - Staffing more collaborative to work with CAAs to get more input to contribute to success of CSBG

Weatherization

- Challenges at BCAEO in April regarding Weatherization staffing (Weatherization Specialist position has been vacation since last April); Kris stepped into role to keep it moving
- Michigan receives second largest amount of funding in nation due to number of low income population
- o Funding
 - PY17 running on FY17 dollars; already committed to programs; runs through June 2018
 - If we have long government shutdown, could be problem drawing down the funds
 - Cost reimbursement 30 days after they spend the money
 - Gave them 2 month advance so they have funding to use if there are delays
 - Hope for continuing resolution or budget approved for FY18 funding
 - If there is a continuing resolution, we will receive 60% of the funds available on July 1 and then will receive the additional 40% once the budget is approved
 - BCAEO is currently working on the State Plan for FY18; using FY16 dollar amounts

Weatherization Change Vision

- BCAEO take Michigan's Weatherization Assistance Program to the next level by improving program performance and quality, expanding and enhancing support, and creating and maintaining a training program that includes a training facility in Michigan
- This change vision will focus on the following: reorganization of State office, training and technical assistance expansion and enhancement, state monitoring stabilization and growth, stronger collaborations with partners, communication plan
- Michigan is the second largest program in the nation so we need a training center in Michigan
- Will hire a training director in April and training support staff
- Need to identify training center locations
- DOE is adding more certificates so we want to train, test, and certify in Michigan
- BCAEO is also hiring a Weatherization Specialist and two technical monitors
- Collaboration/Partnerships with Weatherization leadership team

- o The MCA/BCAEO conference is at Crystal Mountain July 9-12, 2018
- o MCAEO Commission meeting will take place on Monday, July 9th at Crystal

- Mountain and then Commissioners are invited to the Executive Dinner that evening

- o Great sessions; board track; weatherization track; Roma Next Generation
- o Board Member track will have sessions on human resources, finance
- o University of Michigan poverty solutions will be speaking
- o Evening Activities include CAA staff, board members, executive directors

- Susan Newhof shared a draft report with a spotlight on what's being done currently around the issue of Financial Empowerment
- Endorse the proposal from national group; purpose and adopt philosophy

- Workgroup for recommendations was created (Jill, Susan, Kris, Kate, Jessica, Fran); they will meet and finalize recommendations to present at next meeting
