### Influenza-associated Pediatric Mortality

Nationally, 144 influenza-associated pediatric deaths have been reported thus far for the 2019-2020 flu season. Four (4) pediatric influenza (B) deaths have been confirmed by MDHHS during this season.

## U.S. Outpatient Influenza-like Illness Surveillance Network (ILINet)

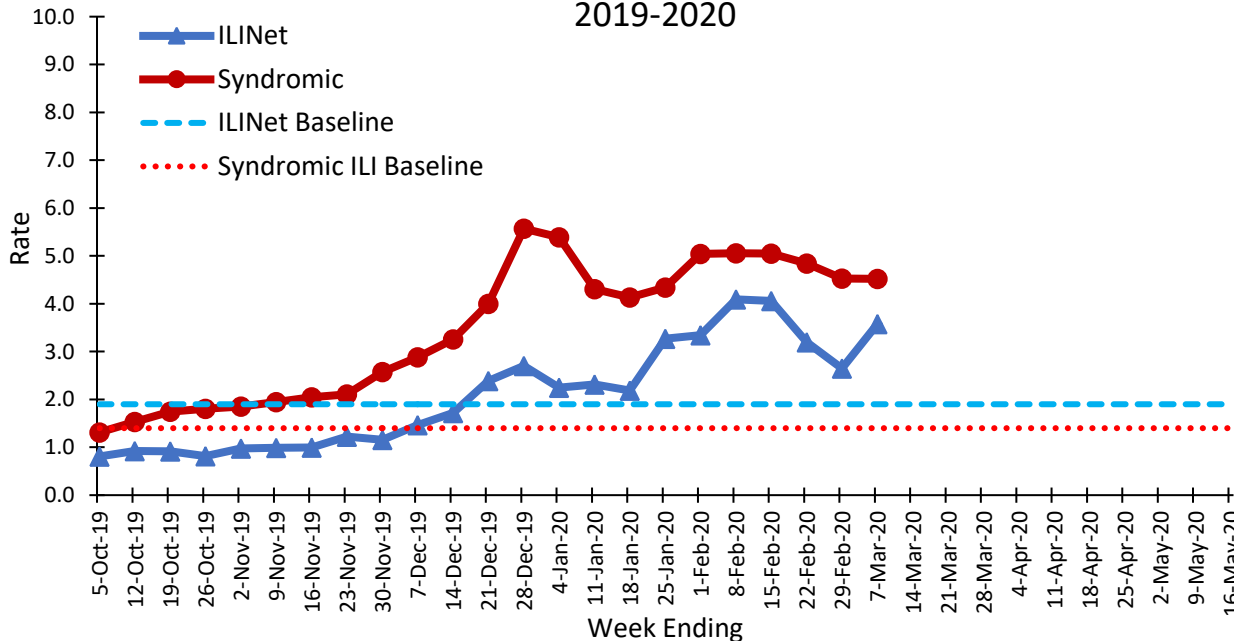
Michigan participates in ILINet, a collaborative effort between the CDC, state and local health departments, and volunteer sentinel clinicians as part of Michigan’s influenza surveillance. ILINet provides data on the total number outpatient visits to health care providers seen for any reason and the number of those patients with influenza-like illness (ILI). For this system, ILI is defined as fever (temperature of 100°F [37.8°C] or greater) and a cough and/or a sore throat without a known cause other than influenza.

### Number of Reports and ILI % by Region in Michigan during this time period:

## Michigan ILI Activity

Regional Baseline\*: 1.9%

A total of 326 patient visits due to ILI were reported out of 9,115 office visits during this period.

\*Regional baseline is determined by calculating the mean percentage of patient visits due to ILI during non-influenza weeks for the previous three seasons and adding two standard deviations

## National Surveillance

In the United States, **5.2%** of outpatient visits were due to ILI. (Last week: 5.1%)  
This is **above** the national baseline of 2.4%

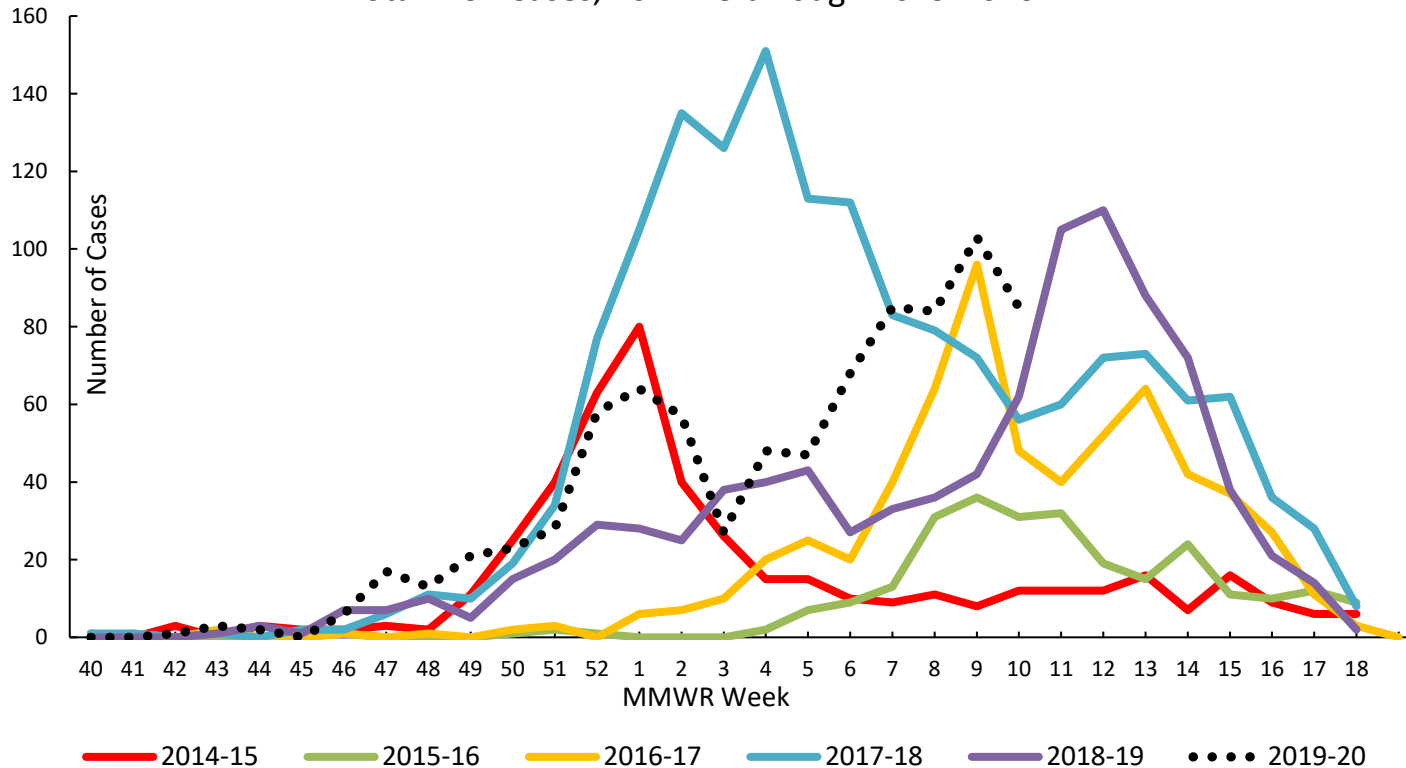

## Influenza Hospitalization Surveillance Project (IHSP)

The CDC's Influenza Hospitalization Surveillance Network (FluSurv-NET) provides population-based rates of laboratory-confirmed influenza-associated hospitalizations from October 1<sup>st</sup> through April 30<sup>th</sup> each year. Michigan participates as an IHSP state in FluSurv-NET for Clinton, Eaton, Genesee, Ingham, and Washtenaw Counties.

There were **85** (6 pediatric, 79 adult) influenza-associated hospitalizations reported to MDHHS for the IHSP during this time period. Since October 1<sup>st</sup>, **840 (127 pediatric, 713 adult)** influenza-related hospitalizations were reported in the catchment area for the 2019-2020 season.

## Join the Influenza Sentinel Hospital Network (ISHN)!

What is it? ISHN is a group of hospitals in Michigan that voluntarily report weekly aggregate counts of influenza positive inpatients to assist MDHHS with statewide flu surveillance

How it works: As a participating hospital in the ISHN, you would complete a brief Survey Monkey every week containing:

- Number of hospitalizations with a positive influenza test by age group during that time period
- The total number of hospitalizations due to any condition during that time period (if available)

The data you provide is aggregated by region and can assist providers and public health in recognizing changes in the age or geographic distribution of flu in this population.

# Laboratory (Virologic) Surveillance

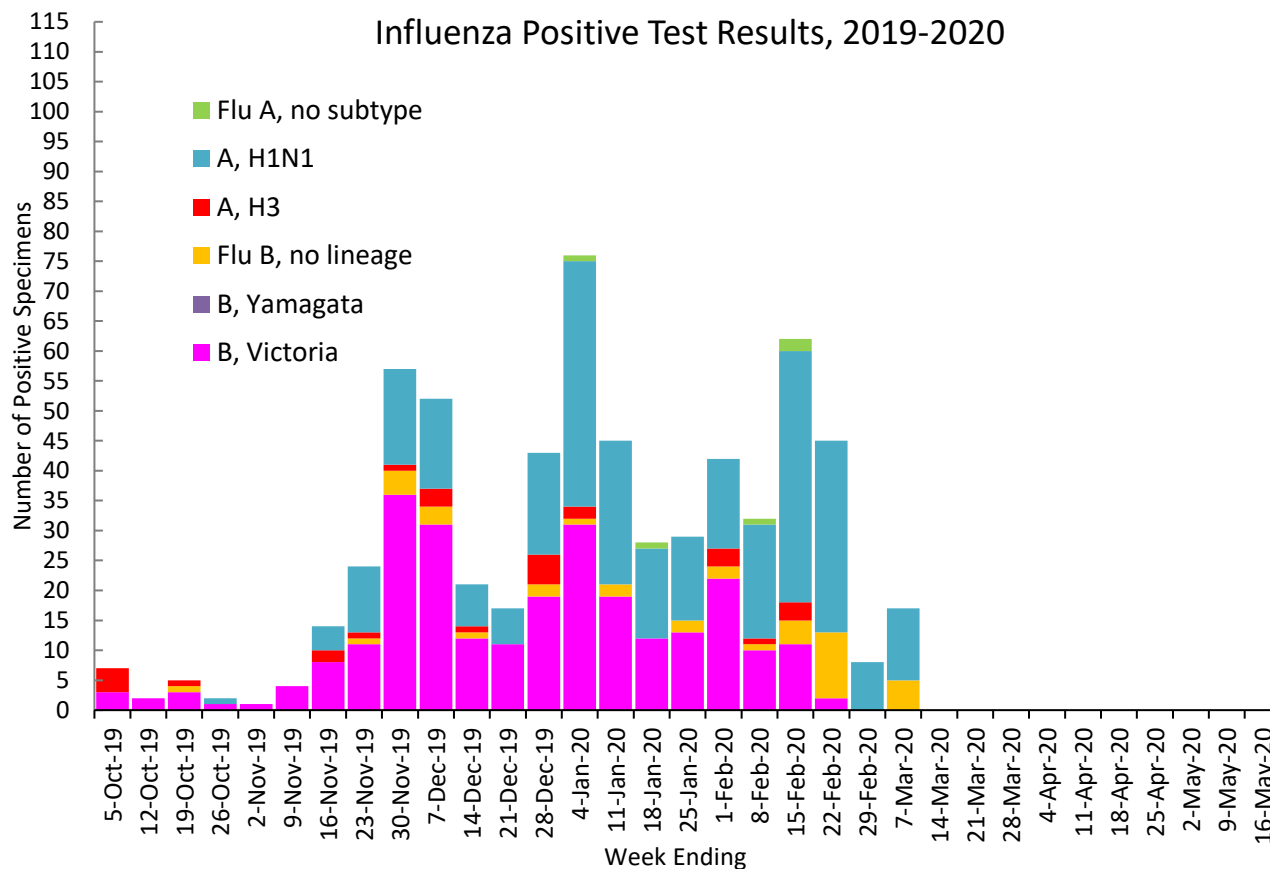

There were **17** new positive influenza results (9C, 1N, 0SE, 7SW) reported by the MDHHS Bureau of Laboratories (BOL) during this time period.

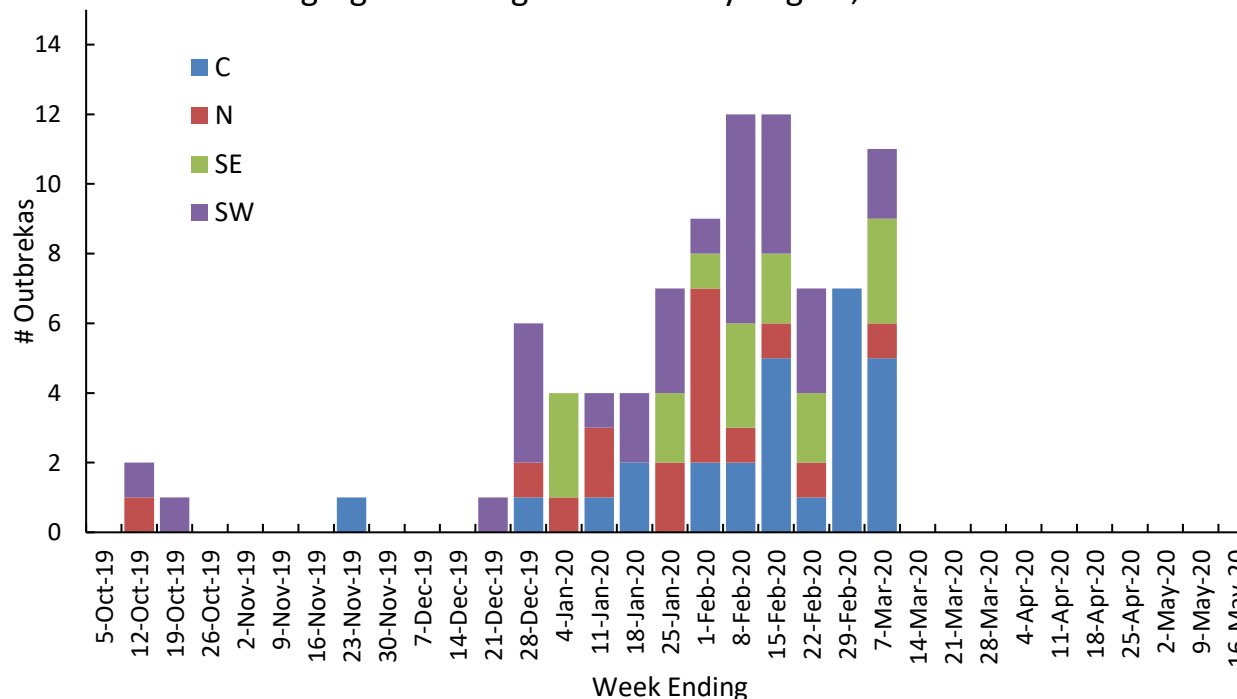

## Influenza Vaccine Updates

### WHO Recommendations for 2020-2021 Influenza Vaccine

The [World Health Organization \(WHO\)](#) has announced the recommended composition of influenza virus vaccines for use in the 2020-2021 Northern Hemisphere influenza season.

The WHO has made different recommendations for the vaccine virus strains to be included in egg-based compared to cell- or recombinant-based vaccines.

### 2020-2021 Flu Vaccine Components Include:

#### Egg-based Vaccines

- an A/Guangdong-Maonan/SWL1536/2019 (H1N1)pdm09-like virus;
- an A/Hong Kong/2671/2019 (H3N2)-like virus;
- a B/Washington/02/2019 (B/Victoria lineage)-like virus; and
- \*a B/Phuket/3073/2013 (B/Yamagata lineage)-like virus.

#### Cell- or recombinant-based Vaccines

- an A/Hawaii/70/2019 (H1N1)pdm09-like virus;
- an A/Hong Kong/45/2019 (H3N2)-like virus;
- a B/Washington/02/2019 (B/Victoria lineage)-like virus; and
- \*a B/Phuket/3073/2013 (B/Yamagata lineage)-like virus.

\*The B/Phuket (B/Yamagata lineage) virus will not be included in the trivalent vaccines.

**The influenza A/H1N1, A/H3N2, and B/Victoria components all are different than the virus strains included in the current Northern Hemisphere influenza vaccine for the 2019-2020 flu season.**

## Influenza Burden Estimates

The Centers for Disease Control and Prevention (CDC) have once again begun to release [preliminary burden estimates](#) for the 2019-2020 influenza season.

Between October 1, 2019 through March 7, 2020 it is estimated that there have been:

- **36 million – 51 million flu illnesses**
- **17 million – 24 million flu medical visits**
- **370,000 – 670,000 flu hospitalizations**
- **22,000 – 55,000 flu deaths**

Additionally, there have been 144 confirmed flu-associated pediatric deaths for the 2019-2020 flu season.
