1. Welcome & Introductions

Angie welcomed everyone. Everyone introduced themselves on the phone.

2. Minutes – Minutes from July 17 approved.

3. COVID-19 Update – Angie

- a. COVID Testing on outpatient (OTPs) in Detroit, Lansing, and Saginaw/Bay City,
- b. Medicaid Telehealth Policy
- c. Recovery High School grants will be going to three agencies: Charlevoix, St. Clair, and Well Spring in Oakland County.

4. Provider Update

- **MACOMB** – School-based so quiet right now. Kids are transient so working on getting follow ups.
- **Catholic Human Services (CHS)** – No update
- **Holy Cross** – Belinda is Meeting with the team and seeing how the process is working. Had a couple positive staff so that slowed them down. They had one person who met the age requirement in July.
- **Great Lakes** – Slow in June, but 4 new intakes recently. GAIN training for their Bachelor's level staff, and Master's level will review and sign off. Parents are pushing for treatment now.
- **Wedgewood** – Primary issues getting staff trained in Motivational Interviewing. Also getting the referrals for the age range.

5. **GAIN Progress** – Anthony has been training Macomb and Wedgewood. Anthony said it has been slow the last month and a half. There are a few people very close to be certified. Last one he sent back was July 20th.
6. **Peer Recovery and FANS** – FANS has not had any face to face meetings. We will be interviewing 3 for the part time position. Then we can start training on the curriculum.
7. **Curriculum** – We have looked at feedback and are working on some of these things with Pam to look over our curriculum. Looking at being some tweaks as we train the first time.
8. **Monthly Reporting – Brooke**
Monthly surveys are due today. They have been more descriptive.
9. **EGRAMS** – Many EGRAMs coming back because work plans are not complete. Sending out Mock up Work plans to PIHPs to help them.
10. **Government Performance and Results Act (GPRA) – Brooke**
Updates – Sent out July monthly report. Statewide at 48% follow up. 79% of youth coming in for marijuana use. Follow up numbers are down.
12. **Site Review Updates** – Completed all the site reviews. Brooke is waiting on last report. We gathered some great information on these reviews.
13. **Future Updates** – Great Lakes is looking to provide services to working with the Abuse/Neglect setting to try to provide mental health services and not just Substance abuse.
14. **Trainings** – Did follow up with Motivational Interviewing training. Will start up in October. Received a list from Wedgewood. Need an updated list from Assured and Great Lakes.
