1. Welcome & Introductions - Kelli welcomed everyone. Everyone introduced themselves.

2. Minutes – No comments. Everyone instructed to send changes to Kelli, if any. No changes. Approved.

3. Update – Angie Smith-Butterwick

- > COVID-19 Vaccinations: Our providers were identified as in the 1C category and will be vaccinated next if so desired. The length of time is still questionable.
- ➤ **Buprenorphine**: The Department of Health and Human Services (HHS) will be publishing practice guidelines for prescribing opioid use disorder and the details in reference to this subject. Effective date is uncertain as of this time, more to come.

Grants:

- Not applying for the Youth and Family Tree application and the details as to why not.
- We are applying for the *Pregnant and Parenting Women (PPW) PLT* for Women's specialty services and we are working with public health. This a system of care where pregnant women will be serviced and the details regarding this, such as locations; Northern Michigan joined with the Opioid Health home in the area, urban; focus on obstetrics and pediatrics. Due beginning of February 2021.
- Newly released Prescription drug overdose; naloxone distribution training and other information regarding this grant.

4. Short Presentations

> Charlevoix County Recovery High - John McLean

A short PowerPoint presentation was delivered regarding Charlevoix County Recovery High School's Round Lake and Safe Harbor Adolescent Recovery Programs. Mention of their location, an explanation of the programs, and all the details associated with these programs. They serve a diverse group. Safe Harbor serves all 83 counties throughout Michigan for young people who are court ordered. Also service private referrals and probation youth in Charlevoix County, suspended kids, truancy youth, juvenile court youth and are Commission on Accreditation of Rehabilitation Facilities (CARF) accredited. Also mentioned were the programming goals for freshmen to juniors. A brief history was also communicated. Questions, comments, and answers were mentioned.

> Wellspring Academy - Brian Spitsbergen

A short PowerPoint presentation was delivered regarding *Wellspring Academy*, Southeast Michigan's Recovery High School Program, located in Farmington Hills. A description of the program's history, mission, purpose, focus, student eligibility and ways the program helps. Currently seeking measurement effectiveness, preparing to officially open next Tuesday. Currently have two students. Also communicated were other details regarding the school. Some of those details include that they conduct recovery and support, as well as other details. They are operating on a public charter since early 2019 an advisory board was established, launching next week, and partnering with Michigan International Prep School as an online school with the intent of going live in the Fall. We focus on anxiety reduction, recovery, and family supports. They are accredited and certified. Also spoke on enrollment. Questions, comments, and answers were mentioned.

➤ St. Clair County Recovery High - Mike McMillan

A short presentation was delivered regarding *St. Clair County Recovery High*, where they have been focusing on day treatment programs since the late 90s, which include mental health therapists 24/7, programming for students through the court, partnering with Port Huron area schools, as well as their own charter school. Submitted a Substance Abuse and Mental Health Services Administration (SAMHSA) grant entitled Bringing Recovery Supports to Scale (BRSS) Technical Assistance Center Strategy (TACS) who paired us up with partners to assist us with determining the need. Currently working on creating a recovery high school. Questions, comments, and answers were mentioned.

NOTE: Angie mentioned that legislation about recovery high schools and is now in the mental health code. An RFP will be implemented, specifically for recovery high schools. PIHPs not included.

5. Provider Update – All Providers

➤ Great Lakes Recovery – Derrick DePietro

Not much activity due to the holidays and Covid-19; low admits and discharges. Barrier is our Master's level clinician has resigned. Needs advice as to how to handle the resignation. No one has applied for the Master level clinician; Angie will send strategies to assist in this process. Judy mentioned Jasmine as a possible subcontractor or other subcontractors who may be available. Angie mentioned training will be done too. Questions were answered.
