1. Welcome & Introductions

Kelli welcomed everyone. Everyone introduced themselves on the phone.

2. Minutes – Motion to approve and a second to approve. Minutes approved.

3. Update on COVID-19 – Angie Smith-Butterwick

PIHPs have recently received all the guidelines for funding from our Department. Providers should have gotten them from PIHPs. If you have not received them you can get them on our website. Most recent one was on food. Ability for residential and AFCs to get food. Encouraging providers to work through Gordon food service and Sysco as much as they can. If not available, arrangements can be made.

Received approval letter for Disaster Application. 5 were approved, not much \$2 Million for each state. John will be in contact with Regions who were approved.

Hotlines are open. Peer line is also open. They are mental health professionals. Cross trained with SUD and mental health. Paying for this with Mental Health block grant.

Provider Update

MACOMB – They are doing 100% telehealth. Most of their MYTIE came from school. They are offering MYTIE now through Telehealth. They currently have 20 so that has picked up and the goal is 25. Currently reaching out to them and working on getting GYPRA follow ups. The adults/Medicare population are difficult because they are not tech savvy. The kids are doing well because they are using their cell phones. Kids seem to like it.

Macomb has Google groups that reach out to the schools. Macomb county Daily is going to write a story about the youth having access to counseling while they are home. Went from 0 Intakes to about 4 a day now.

CHS – One provider, Becky, who does MYTIE. Telehealth going on week 4. Most MYTIE referrals come from District court and this has been down. Court will be doing some Misdemeanor hearings in May and hope this will pick up.

Assured – Doing same thing everyone else has mentions. They have gone Telehealth platform also. Therapist have adapted well. The staff is all on board and eager to comply with what they must do.

Darlene – (Detroit/Wayne) They are in the mist of everything. They have only had 2 COVID deaths. Trying to put a lot of different things in place.

Judy – Doing Narcan training over the phone. Delivering Narcan as soon as they get the training. Darlene 869 overdoses and down from 915 in 2017.

Holy Cross – They had a decrease in Intake. They were contacted and asked if they were still taking referrals. Wondering if others were having this issue?

Great Lakes - Great Lakes has been sending out weekly emails to the people who usually refer to let them know they still have openings. Referrals are slowing down in the UP because no one is in the offices, no one is drug testing, no one is encouraging these kids to get treatment. Medicaid referrals have decreased, but the private insurance and Native health have increased.

Wedgewood – Not getting any reports that they are not fine. The outer counties are having issues with technology. They are using ZOOM. MYTIE has 4 and hoping to ramp that up.

4. GAIN Progress – Angie

Let us know who needs the training and we will set something up.

PIHPs need to work together to try to find an assessment that will work for everyone to take the place. They will have to determine the training after something is set. Only GAIN currently covers adolescents. The PIHPs will decide what version. We recommendation is the CORE because this gives a diagnosis and a level of care. ASI does not require Master's level, but must follow the State's guidelines which is ordered to give a diagnosis you have to be Master's level therapist.

- 5. Peer Recovery and FANS Angie did the PD, but there is currently a hiring freeze.
- 6. Curriculum Heather updated the curriculum and noticed enabling and codependency section was missing. When the administration can pull away from COVID they will look at the curriculum.
- 7. Work Plan Attached the Work Plan. Updated it with the new criteria during COVID.

8. Monthly Reporting – Brooke

Two surveys due so get them in. Everyone did well with getting their surveys complete.

9. EGRAMS – No issues at this time.

10. GPRA – Brooke

Updates – Follow ups have been good. Just put on GPRA website a table to see when the GPRAs were done. Statewide at 58%. 2 Grantees within the 80% follow up rate. Will be sending GPRA tracking update soon. Verified every site what Gift cards were given. 2 sites will need gift cards soon. Going to try to get Amazon to send them directly to you.

11. Site Review Updates

Hopefully, we can set them up for July and August. We will have to see if we can travel

12. Future Updates -

Talked about Carry Forward funds. We are still waiting to find out about the funds.

Darlene shared that what they put on grant is COVID Rapid testing on Mobile Unit. Nurses will bon on the unit as well. Asked for more PPEs. Trying to do a massive outreach on who is sick and who needs treatment and triage to get them where they need to go. Put some beds available for neighboring PIHPs. Wayne county will be first but will try to help with some beds.

13. Trainings – GAIN training will be followed up on and get the training available.
