Partner Highlight

MiTracking has been collaborating with Michigan State University Occupational and Environmental Medicine (MSU OEM) since summer 2017 on work-injury and illness data. From this partnership, MiTracking's Data Portal now hosts workers' compensation and work-related death data. Recently, MSU OEM was able to highlight their work with MiTracking at the National Institute for Occupational Safety and Health (NIOSH) grantee meeting. The meeting took place at the Colorado Department of Public Health and Environment with NIOSH and other states doing similar work. The demonstration was well received, especially the mapping ability. Next up, MSU OEM and MiTracking will be adding adult lead poisoning to the data portal. Collaborations like this one allow us to provide new and innovative data to the public. ICD Codes



Starting on October 1, 2015, hospital record data (all causes of hospitalizations and emergency department visits) changed to a new, more detailed coding system. The coding change means that hospitalizations data from 2014 and before cannot be compared to later years. It also makes 2015 hospitalization data unreliable itself. Differences in counts and rates in years prior to 2015 compared to years after 2015 could be a result of this coding change and not an actual difference in the number of events. MiTracking is currently working on 2015 data and reports to show the unique effects of the coding change. These reports will be available on the MiTracking portal sometime in 2019.
