#### **MINUTES**

#### I. Call to order, introductions – Dr. Joneigh Khaldun

The meeting was called to order at 1:31 PM by Dr. Joneigh Khaldun, Chair. The role was taken, and a quorum of voting members were present.

#### II. Review and adopt September 2020 CLEEC Meeting minutes – All

Lyke Thompson motioned to adopt the September 2020 CLEEC Meeting minutes. Danielle Brown seconded. The minutes were unanimously approved.

#### III. MDHHS COVID-19 Updates – Dr. Joneigh Khaldun

Dr. Khaldun provided an overview of recent MDHHS COVID-19 Updates. Most recently, the Michigan Supreme Court found Governor Whitmer did not have the authority to issue the Executive Orders for COVID-19 since April 30, 2020. The Public Health response is still to save lives, conduct testing, contact tracing, and investigations.

The case rate is 81.6 cases per million people, the highest case rate since May 1, 2020. The upper peninsula is experiencing 311 cases per million people and a high percent positivity.

Ninah Sasy presented an overview of the new Drinking Water Quality Concern System.
