Overdose Awareness and Free Naloxone Day, August 31st, 2019 Request for Pharmacy Participation

In recognition of the ongoing public health emergency and State-wide efforts to reduce overdose deaths – which rose to over 2,686 in 2017 – the Michigan Department of Health and Human Services (MDHHS) and Licensing and Regulatory Affairs (LARA) is requesting your participation in a statewide opioid antidote (naloxone) distribution day on August 31st, 2019. On this day, naloxone will be made available at no cost to anonymous recipients who present themselves at pharmacies that have obtained standing orders from the Chief Medical Executive or a Michigan licensed physician. Should your pharmacy choose to participate in this statewide event, naloxone will be delivered to your pharmacy prior to August 31st, 2019. The naloxone is being made available to pharmacies through federal funding administered by MDHHS.

Participating pharmacies will be required to have a valid standing order and must agree to the conditions set forth below.

Prior to August 31st, 2019:

- As part of the agreement to participate in the program, the registered pharmacist-in-charge (RPIC) of a participating pharmacy will sign a certification indicating that he or she has reviewed this document and agrees to comply with the rules of the program.
- MDHHS will purchase the naloxone, which will be shipped from the manufacturer to the participating pharmacies. The naloxone provided for Overdose Awareness Day must be segregated from the pharmacy's regular prescription drug stock, with any remaining naloxone returned to MDHHS following the Overdose Awareness Day. Reconciliation reports will need to be filed with MDHHS on forms provided to the participating pharmacies.
- Pharmacies will receive from MDHHS a logging template, a reconciliation document and recipient and pharmacy materials. Materials shall contain information on product use, recipient eligibility, and addiction treatment and recovery resources.
- Only one naloxone kit is to be distributed per individual and should only be distributed to those over the age of 14. ID will not be required upon distribution.

On August 31st, 2019:

- Participating pharmacies will post the eligibility information to indicate that professionals, professional entities, first responders and first responder entities, as defined in the Michigan Standing Order, are not eligible to obtain the opioid antidote through this program.
- Identify a pharmacist or pharmacists to be on duty from the time the pharmacy or pharmacy department opens, through the time that the supply of opioid antidote

is available and provide this program document to every participating pharmacist. The participating pharmacist(s) will sign the necessary forms, indicating that they have reviewed this program document and agree to comply with the rules of the program. Only Michigan licensed pharmacists will be permitted to distribute naloxone.

- Enter onto the logging sheet, the name, address and registration number of the pharmacy, and names and license numbers of assigned pharmacist(s). The pharmacist shall also provide allotment information, including the quantity received, NDC number, lot number(s) and expiration dates(s) for the naloxone.
- For each recipient who requests a naloxone kit, the pharmacists at the participating pharmacy shall:
 - Provide the recipient with the resource materials.
 - Make inquiry as to whether the recipient is over the age of 14.
 - Advise that the naloxone should not be administered to persons with known allergies to any of the ingredients.
 - Assign each recipient one of the pre-printed numbers on the logging sheet.
 - Check the boxes next to that number on the logging sheet reflecting,
 - Receipt of the resource materials;
 - An indication that the recipient is over 14 years of age;
 - An indication that the recipient has been advised not to administer naloxone if the person to whom it is proposed to be administered has a known allergy.
 - Place the distributing pharmacist's initials in the final box, indicating affirmation of the steps taken.

After the completion of Opioid Overdose Awareness Day, the participating pharmacy shall:

- Reconcile the quantity of naloxone received at the start of the day, with those distributed, and those on hand at the end of the day.
- Maintain a copy of the logging sheet(s), which shall be readily retrievable upon request by the Michigan Board of Pharmacy.
- Follow MDHHS instructions regarding the return of any quantity of the allocation that remains at the end of the distribution.
- Provide a copy of the logging sheet to MDHHS within 3 days of the distribution, per MDHHS instructions.

Compliance with this protocol will relieve participants in this program from having to enter the identity of the recipient into the pharmacy profile or any other record keeping system. The completed logging sheet provided by MDHHS will be deemed by the Board to be the requisite "other system of records" under Michigan's Standing Order. Naloxone delivered to recipients pursuant to this program should not be included in any drug utilization review and should not be processed through insurance.
