TOPIC SUMMARIES

I. Welcome and Introductions – Larry Scott

Mr. Scott welcomed the Transformation Steering Committee (TSC) and two new people were announced; Sandra Boyd a MA Degreed intern with Washtenaw County working with Marci Scalera. Also, Steven Henry, a peer trainer who works in OROSC as a community health trainer working with Pam Werner. Everyone introduced themselves.

II. Agenda and Minute Review - All

At the request of Marci Scalera, today's agenda now includes "standing order and challenges with the prescription side of things." The November 16, 2017 minutes were reviewed and approved by consensus.

III. BHDDA Leadership Update – Larry Scott - Tom Renwick absent

MDHHS Notice of Proposed Policy Changes for Medicaid

The 298 RFI release is due by February 13 and a response is due by February 28, 2018.

Tribal Consultation Meeting

This meeting took place last week where a meeting convened with all the Michigan Federally Recognized Tribes. Discussion took place on topics of concern, such as children and family behavioral health. No negative feedback from the tribal entities regarding SUD services. All tribes are separate entities and must be regarded as such. Please review your provider networks

and assure cultural competency and expert advocacy is occurring with tribal entities. Also, other important information was communicated to the group regarding the importance of bi-directional communication between Native American Tribes and Child Protective Services (CPS). Questions were asked, and ideas were contributed. Ms. Darlene Owens reported that Detroit is providing Naloxone training to American Indian Health Services.

Meeting with Deans of Medical Schools in Michigan

An overview of this meeting was communicated to the group. The department sought to know how and what the medical students are being taught about the opioid crisis. We learned that courses are now mandatory regarding opioid education on multiple levels and include prevention, health, wellness, and recovery. Various members mentioned training they are rendering regarding this subject of educating the medical community. Questions were asked, and ideas were contributed.

IV. OROSC Updates

A. State Epidemiological Outcomes Workgroup (SEOW) - Su Min Oh

Two Fact Sheets have been created: Drug Overdose Deaths involving Opioids in Michigan 1999-2015 and People in Substance Use Treatment for Opioids in Michigan 2001-2016. An overview of the statistic details of these fact sheets was communicated to the group. The fact sheets will be posted on the OROSC website soon. Dr. Oh will send fact sheets by e-mail to anyone from the group requesting it. As soon as they are complete, both will be posted on www.michigan.gov/bhrecovery under *Reports & Statistics Spotlight*.

MDHHS Population Health – Working with Population Health on two Center for Disease Control (CDC) grants.

MDHHS HIV-STD Section – Working with this section on HIV-STD projects.

B. State Targeted Response (STR) to the Opioid Crisis Grant – Brittany Leek

Ms. Leek communicated to everyone the progress of the STR continuation application for the 2nd grant year starting May 1, 2018 to April 30, 2019. Many trainings are taking place within the next three months, predominately heavy on implementation. Also communicated, other activity taking place in the project, such as Native American tribal media activity (Pow Wows, Facebook, Twitter, among others) and *Screening, Brief Intervention, and Referral to Treatment (SBIRT)* is also being incorporated. She communicated the progress on *Motivational Interviewing, MISSION Re-entry, Strengthening Families,* and the many *Naloxone* trainings, *and Red Project,* as well as others. More information coming soon on the statewide media campaign. Questions were asked, and answers were offered.

C. Partnership for Success (PFS) Grant Project – Lisa Coleman

Ms. Coleman introduced herself and gave an overview and update on the status of the PFS grant and stated that we are in year three of a five-year grant, and the grant focus; reduction and misuse of alcohol for underaged individuals 12-20 years of age and prescription drug misuse and abuse 12-25 years of age. She, also, mentioned the Six PIHP regions being contracted with, as well as eight high-risk counties for the grant focus/priorities target population areas. She mentioned how they are working on building relationships with primary care and the initiatives for referrals into prevention programming and focusing on health disparities and the various populations affected. She, also, communicated other information regarding coalition progress/growth. Also, Ms. Coleman and staff are involved in preparing the continuation application. Questions were asked, and answers were offered.

D. Peer Recovery Coach Training and Certification - Pam Werner

A question and answer (FAQ) document was distributed to the members. Ms. Werner communicated about the details of the document, such as 140 applications having been received for grandparenting and 23 trainer applications. All documents are on the OROSC website at www.michigan.gov/bhrecovery under *Announcement Spotlight*. She, also, mentioned some of the FAQs people asked and the answers she supplied for those questions. Ms. Werner provided answers to various questions the TSC asked.

E. Medical Services Administration (MSA) Policy Provider Fitness Criteria and Workforce Implications – Pam Werner

Ms. Werner shared more about the MSA Policy, as it relates to fitness criteria and workforce implications. She communicated to everyone the specific details of this document. She sent the policy out to many recipients. Medicaid received 400 public comments, as well as other information related to the document. Mr. Scott, also, related some information about this policy to the group. Ms. Werner provided answers to various TSC inquiries. Communication from the MSA will be sent out soon.

F. Michigan Youth Treatment Infrastructure Enhancement (MYTIE) Initiative Grant Update - Heather Rosales and Angie Smith-Butterwick

Ms. Rosales communicated about what is taking place with the MYTIE grant; past, present, and future. She, also, is working on the continuation grant. The *Global Appraisal of Individual Needs (GAIN-I CORE)* and *Adolescent Community Reinforcement Approach (A-CRA)* training is in process for this month, either in person or online for the next few months. Other trainings include motivational interviewing, *Trauma focused cognitive behavioral therapy (TF-CBT)* will also be taking place. Year 2 will include programming and expansion of the providers of the MYTIE Cohort. She mentioned they are in the 2nd quarter of the Implementation Grant. Mr. Tyson requested technical assistance. Mr. Scott encouraged and reminded everyone of the MYTIE Financial Map on the OROSC website at www.michigan.gov/bhrecovery; click on Treatment and then the financial map. The Strategic Plan will be shared with the TSC. Answers were provided to various questions the TSC asked.

G. Gambling Prevention and Treatment Project – Alia Lucas

Ms. Lucas related information, such as speakers, among others about the upcoming Gambling Symposium to be held on March 2, 2018. To register, click on 2018 Gambling Disorder Symposium. Mr. Scott encouraged the group to take advantage of the training and to keep in mind the risk and protective factors, as well as other information relevant to gambling treatment. Ms. Lucas answered questions asked by the TSC.

V. Update and Discussion on 42 CFR Part 2 Final Rule – Angela Smith Butterwick

The Substance Abuse and Mental Health Services Administration (SAMHSA) released the new rule on January 2, 2018. There is a five-hour session on January 31, 2018 and you may register through SAMHSA. Ms. Smith-Butterwick explained the specifics about the rule, such as methods of payment, and quality assessment, as well as other information. This is supplement to the rule that was issued January 18, 2017. Ms. Smith-Butterwick will send to Ms. Bullard, and Ms. Bullard will e-mail everyone the link to the final rule. It will be available on the OROSC website soon. Ms. Smith-Butterwick answered questions asked by the TSC.

VI. Global Appraisal of Individual Needs (GAIN-I CORE) Update and Discussion – Angela Smith Butterwick

Ms. Smith-Butterwick related to everyone an update on *GAIN*, as well as discussion. The first training is January 30, 2018 and January 31,2018 (two full days) at Community Mental Health Association of Michigan (CMHAM) (formerly MACMHB). All PIHPs must identify two to four people to send to the training. Once information is received, they will be added to the list of attendees. She, also, gave other detailed information about this training. The second *GAIN* training will be online only on February 13, 2018, as well as other information about the second training. Questions were asked, and answers were shared.

VII. PIHP and SAPT Directors Announcements and Innovative Practices Update – PIHP/SAPT Directors

Darlene Owens (Region 7 - Detroit Wayne Mental Health Authority (DWMHA): Received an epidemiological (EPI) report from Dr. Cynthia Arfken on the SUD Oversight Policy Board, showed a decline in opiate and heroin deaths in Wayne county. She furthermore explained some of the actual statistics referring to the decline. Advertising and town hall meetings are on track as explained at the last ROSC/TSC meeting. The mayor of Detroit wants DWMHA to work on addressing the homeless population. She also mentioned the various projects taking place within the region; Western Wayne, Downriver, Angel Project with Michigan State Police, Hope, Not Handcuffs by Judge Davis, and Detroit FAN Project, by Andre Johnson.

Marci Scalera (Region 6 – CMH Partnership of Southeast (SE) Michigan): Ms. Scalera explained what is taking place for training in SE Michigan about the Red Project and innovative strategy events. She further related information that is taking place regarding Naloxone, prescriptions, law enforcement, among other items, such as a strategy to have peers at the hospital after a person has been revived using Naloxone. Ms. Scalera will e-mail question Standing Order information to Mr. Scott, who will in turn forward it to MDHHS Population Health

Joel Smith – (Region 4 – Southwest Michigan Behavioral Health) – Mr. Smith related to everyone the success happening in their region regarding Naloxone. He explained how they will be creating a doctor to doctor curriculum, as well as other innovations taking place.
