TOPIC SUMMARIES

I. Welcome and Introductions – Angela Smith-Butterwick

Ms. Smith-Butterwick welcomed the Transformation Steering Committee (TSC); Everyone introduced themselves.

II. Agenda and Minute Review - All

The January 17, 2019 minutes were reviewed and approved.

III. BHDDA Administration Update – Angela Smith-Butterwick

298 Update: The first technical assistance session for 298 pilots took place on February 27, 2019, which covered strategic planning. The strategic plan will be focused on the provisions of services and activities. The 298 strategic plans are due the end of May. *Later in the meeting, an update was received indicating the 298 pilots were given a 30-day extension for the strategic plans, so they are now due June 30, 2019.

Substance Use Disorder (SUD) licensure rules: There was some discussion among the membership regarding level of care requirements and applying for licensure. However, there were no new updates to report.

State Opioid Response (SOR) Supplemental Award Notice: OROSC received the award notice; 14.5 million dollars was offered. The State of Michigan accepted that amount. OROSC has until April 1, 2019 to submit the plan for the awarded funding.

National Association of State Alcohol & Drug Abuse Directors (NASADAD) sent an email communication on March 20, 2019, indicating the next installment of FY19 funding, which is expected to be one billion dollars, will be awarded later this fiscal year.

IV. OROSC Update – Angela Smith-Butterwick and OROSC Staff

A. Opioid Morbidity and Mortality Data – Su Min Oh

Dr. Oh stated the draft report that she shared at the January meeting has been finalized and approved; the report is available on OROSC's website. An application has been submitted to Council of State and Territorial Epidemiologists (CSTE) for funding a short-term project. The project will target and collect 2016 data for 18 substance use and mental health indicators. The project will start the week of March 24th and will be complete by the end of June.

B. Neonatal Abstinence Syndrome (NAS) Initiatives – *Angela Smith-Butterwick*Ms. Smith-Butterwick reported the tribal project is going really well. They have some staff in place to work with the tribes on NAS. They developed a brochure to hand out to pregnant mothers. She met with Hurley Hospital on March 18th to potentially start a rooming-in project. OROSC is trying to figure out the funding. They are hoping Hurley Hospital will dedicate four rooms for the project, so mothers with infants in the neonatal intensive care unit can stay in the hospital with them during the withdrawal period. This will only be available for mothers in treatment. The estimated length of stay for infants is twelve days. A couple other hospitals are being looked at for this project, including Covenant in Saginaw.

C. Consumer Relations – *Colleen Jasper*

Ms. Jasper shared some upcoming events and activities with TSC members. There will be a Michigan ACE Initiative Conference held on May 23, 2019 in East Lansing, at the Eagle Eye Banquet Center. Its primary objective is to reduce Adverse Childhood Experiences (ACEs) in Michigan. The Annual Peer Conference will be held May 29-31st in Lansing, at the Lansing Center. Anti-Stigma Day is July 25th; the event will be held in Lansing at Lansing Community College's downtown campus. There was a Trauma Recovery Empowerment Model training the first week of March. There will be a 3-day group therapy training held later this year. There will be an Eye Movement Desensitization and Reprocessing (EMDR) training scheduled after June; one will most likely be held in Lansing. If possible, another will be held in Saginaw. OROSC is pursuing a peer-run (Peer Support Specialist) respite for individuals with moderate to medium crisis, to help alleviate the waitlist for hospitalization. It would be funded through the Community Mental Health system. Ms. Jasper is working on a wellbeing skills training for individuals to alleviate suffering.

D. State Targeted Response (STR) – *Brittany Leek*

Ms. Leek indicated that she has not received a response regarding the no-cost extension. She anticipates notice will be received the first or second week of April. The JVS International Survey has been submitted.

Ms. Leek shared that The Michigan Open Group (MI-Open) provided an excellent presentation at the Michigan Senate. MI-Open, in collaboration with Harvard University, will be hosting a summit on May $10^{\rm th}$ in Ypsilanti. The topic is on opioid prescribing recommendations, guidelines, and policies. Ms. Leek will send the registration information out to TSC members. The semi-annual prescription "Take-Back Event" will be held statewide on April $27^{\rm th}$.

Ms. Leek shared current tribal activities. The Pokagon Band has begun broadcasting their "Clean Body, Clean Spirit" media campaign. Radio broadcasts are now up, and the social media broadcasts will be up at the start of April. Billboard signs will be posted soon on I-94 and US-31. A Regional Opioid Symposium is coming up on April 4th; it will be held at the Little River Casino Resort in Manistee.

Upcoming trainings: Medication Assisted Recovery Services (MARS) Training March 26th - 27th in Grand Rapids and Project Assert April 8th - 9th in Kalamazoo

E. State Opioid Response (SOR) – Kelsey Schell, Brittany Leek

Ms. Schell shared that all 10 Prepaid Inpatient Health Plans (PIHP) contracts have been signed. There are couple amendments that need to be signed. Training contracts are starting to go through; there are no dates yet for the SOR trainings. The monthly SOR report is due March 29th.

F. Partnership for Success (PFS) – *Lisa Coleman*

Ms. Coleman indicated that the PFS Grant expanded into three additional sites (Eaton County, Van Buren County, and Empowerment Zone Coalition in Detroit). Their expectation is to engage with primary care and focus on the Screening, Brief Intervention, and Referral to Treatment (SBIRT) implementation. In addition to referring to treatment, to also refer to prevention programming. There are nine communities running the Prime for Life program, five communities running the Strengthening Families program, and two communities with Active Parenting. There was an Engaging with Primary Care in the Behavioral Health System training held the end of February. At the end of March, there will be an in-person meeting with the communities. OROSC has contracted with Prevention Solutions to provide sustainability training. There will be two online courses and in-person training in August 2019. A carry-forward funding request was submitted; OROSC is still waiting for a response. Questions were asked and answered regarding Guiding Neuroscience, Epigenetics, ACEs and Resilience (NEAR).

On April 5, 2019 there will be an Older Adult Wellbeing Initiative technical assistance session held at CMHAM in Lansing.

G. Gambling Prevention Project – *Alia Lucas*

Ms. Lucas indicated it is her understanding that the allocation letter for the Gambling Disorder (GD) funding has gone out to the participating PIHPs. She received confirmation from Grants and Purchasing that the funding disbursement should be effective as of April 18, 2019. Ms. Lucas is in the process of convening a time for a monthly conference call to provide GD prevention updates. There is training for GD Prevention Coordinators. There are currently 32 individuals trained and 18 who are registered to train. Ms. Lucas discussed the Gambling Disorder Symposium which was held on March 1, 2019. Questions were asked and answered

H. MYTIE Grant – *Heather Rosales*

Ms. Rosales shared that they are currently working on the youth peer curriculum, which is based off the Washington Model. It is for individuals ages 16 & 17 with a substance use disorder. The peers with be ages 18-25. If anyone would like to join the workgroup, contact Heather Rosales or Matt Haston. Ms. Rosales discussed data acquired for future financial maps. There will be a training this year for motivational interviewing. There will not be another Adolescent Community Reinforcement Approach (ACRA) cohort this year due to

the cost and number of people who attended last year. The next provider collaborative meeting is scheduled for May 2, 2019.

The TSC members discussed adolescent detox and the absence of medication assisted detox facilities for adolescents.

I. Training – Angela Smith-Butterwick

Ms. Smith-Butterwick indicated that there will be upcoming trainings for the Substance Abuse Prevention and Treatment (SAPT) Block Grant. They will be offered by Community Mental Health Association of Michigan (CMHAM). Ms. Leek added that STR and SOR trainings are coming soon.
