#### **TOPIC SUMMARIES**

#### I. Welcome and Introductions – *Larry Scott*

Larry welcomed the Transformation Steering Committee (TSC) and everyone introduced themselves.

#### II. Agenda and Minute Review - All

Today's agenda is approved, and the September 21, 2017 minutes were reviewed and approved by consensus.

# III. BHDDA Leadership Update – Tom Renwick

# **MDHHS Notice of Proposed Policy Changes for Medicaid**

The policy is on the OROSC website and all members are encouraged to review and comment.

#### 1115 Waiver and 298 Activity.

Tom related to the group the various activity and progress occurring with the 1115 Waiver and 298, some of which include:

- 1115 Awaiting approval from the feds.
- 1115 Meetings to be scheduled with Centers for Medicare and Medicaid Services (CMS) for discussions to take place.
- 298 Barriers to be sent to the legislature for review.

- 298 Michigan Public Health Institute (MPHI), the facilitator, has met with providers, Prepaid Inpatient Health Plans (PIHP), advocates, consumers, and Community Mental Health Service Providers (CMHSP) sharing information across the state, collecting concerns and starting conversations.
- 298 Pilot process
- 298 U of M selected as the pilot evaluator and will be actively involved with the core team and other stakeholders and advocates, among other activity.

Questions were asked, and answers were shared with the group.

• As requested at the September 21, 2017 meeting, Tom reminded the TSC to provide feedback on time/distance access related standards. TSC weigh-in and feedback is important and appreciated. He also spoke on parody related to physical and mental health services.

#### IV. OROSC Updates

- **A.** State Epidemiological Outcomes Workgroup (SEOW) *Su Min Oh* **2017 Epidemiological (EPI) Profile:** Still awaiting approval from the Communications office. She also mentioned various details of the EPI Profile.
- **B.** State Targeted Response (STR) to the Opioid Crisis Grant *Brittany Leek and Angela Smith-Butterwick* Brittany gave an overview of the STR and all activity taking place within those projects, such as reporting, training, prevention and treatment initiative, signed agreements ready progress thus far. She also spoke about and explained the Michigan Opioid Collaborative (MOC) and its progress in Michigan. Also explained was NarcsCare conducting BETA testing with Kroger Pharmacy, and Michigan Automated Prescription Service (MAP) as they both relate to the STR. Further discussion took place regarding medicated assisted treatment (MAT) as it relates to the STR. Larry related information about the STR No-Cost extension status.

#### C. Peer Recovery Coach Training and Certification - Pam Werner

Pam talked about the Recovery Coach policy draft that is moving forward and once approved it will be distributed widely. She also let everyone know about the various credentials, such as Genesee, Connecticut Community for Addiction Recovery (CCAR), Michigan Certification Board for Addiction Professionals (MCBAP), and what the requirements are that must be met. The training will begin after the courses and individuals are identified. She also announced the hiring of a new state trainer by the name of Mr. Steven Henry from Detroit and communicated his background. Further discussion took place about this subject among the various members. Questions were asked, and answers were offered.

# **D.** Medical Services Administration (MSA) Policy Draft Provider Fitness Criteria and Workforce implications – *Pam Werner*

Pam shared the MSA Policy as it relates to fitness criteria and workforce implications. Many public comments were made. BHDDA has also sent a formal response requesting a meeting prior to the policy being finalized.

### **E.** Consumer Relations – Coleen Jasper

Colleen explained to the group programs and projects taking place within Consumer Relations. Some of those programs and projects include 48 drop-in centers serving 4,500 individuals in the state, center closings, and center openings. Currently looking at new areas for centers that will focus more on moving people back into the community. Also creating a respite house of which there are shorter stays, peer-to-peer run, recovery coaches which will reduce costs and waiting lists for admission into the hospital.

She also talked about the technical assistance continuation for contract renewal. Attended a conference in Boston about disabilities called *Alternatives* and explained various aspects about the conference. Also connecting to the cancer society about smoking cessation and looking at what other states are doing. She also talked about Trauma and mentioned that they will be holding two trainings; Eye Movement Desensitization Reprocessing (EMDR), and Trauma Recovery Empowerment Model (TREM) during the Spring, Summer, and Fall 2018.

V. MYTIE Grant Update - Heather Rosales and Angie Smith-Butterwick — At present closing out the planning grant. Heather talked about motivational interviewing and face-R scoring training of which four providers (Wedgewood, Holy Cross, Great Lakes Recovery, and Sacred Heart) who will be trained that will start the beginning of January 2018, and occur monthly. Working on the year-end report. Implementation grant began on October 1, 2017. A community outreach worker will be hired and encourage everyone that if you know someone who went through treatment to inform them of the availability of this position.

## VI. Gambling Prevention and Treatment Project – Alia Lucas

Alia introduced herself and informed the group about her background. She also introduced guests Lori Mellow, and her background. Alia explained to the group about gambling prevention and treatment and what is happening within the gambling project. A Gambling Symposium will be taking place in 2018 of which she related the expectations they will be seeking to accomplish. Lori continued to talk about the Symposium and introduced Peter Harrington who mentioned the low recovery rate and how they are looking to increase the recovery rates. Gambling information was distributed to the group. Alia encouraged everyone to visit the gambling website at <a href="https://www.michigan.gov/gamblingdisorder">www.michigan.gov/gamblingdisorder</a>. In addition, Alia also mentioned the large media campaign promotion taking place for gambling. Larry pointed out to the group the correlation and commonality between gambling and co-occurring disorders SUD prevention and treatment. He also said Alia, Lori and Peter will be our new TSC members.

#### **VII. PIHP and SAPT Directors Update** – *PIHPs/SAPT Directors*

**Darlene Owens (Region 7 - Detroit Wayne Mental Health Authority):** Darlene explained to the group that Detroit has a prevention and treatment advertising campaign with Scripps Broadcasting, on ABC, channel 20, radio stations, as well as various social media, such as Facebook and Twitter, among others. She also said they are working with such agencies as the U.S. Drug Enforcement Agency (DEA), Federal Bureau of Investigation (FBI), to name a few, as well as conducting Town Hall meetings. Coalitions are doing a great job. Synar awards ceremony for vendors who do not sell tobacco to youth will be taking place on November 21, 2017. Questions were asked, and answers were shared.

Marci Scalera (Region 6 – CMH Partnership of Southeast Michigan): Marci said they have many initiatives/innovations taking place now and in the future. She told what each of those initiatives and innovations are and plan to be. Some of the initiatives include STR projects, such as RED, and Overdose Response Team, among others. Another engagement center opened in Lenawee County. She also talked about Monroe County's engagement center and explained some of the various aspects taking place there. Numerous Naloxone trainings are being conducted. A question and answer session took place.

# Stephanie VanDerKooi (Region 3 - Lakeshore Regional Partners)

Stephanie explained what is taking place in Region 3, some of which they have produced PowerPoints on "Why You Should Care about Opiates," for adults, "Why is the Heroin Epidemic Happening," and "How to Talk to your Children About It," among others. Muskegon now has five treatment providers. Completed Strengthening Families Training.

**Joel Smith** – (**Region 4** – **Southwest Michigan Behavioral Health**) – Joel said that region four has developed a train-the-trainer model for law enforcement, partnering with the Grand Rapids Police Department *Red Project*.

#### VIII. Announcements and Innovative Practices – All

Population Health will conduct a presentation on *Hepatitis A* at the SUD Director's meeting tomorrow, November 17, 2017. Larry urges all the TSC members to stay abreast and connected with your local health departments about the hepatitis A outbreak, especially in high-risk areas.
