OROSC Updates –Larry Scott

Proposition One (1) Marijuana

Workgroup created whose goal is to push marketing in the forms of awareness campaigns, a toolkit, a state level action plan rollout to stakeholders and community partners, goal is to reduce access to marijuana. With the help of this group, Su Min will be identifying indicators in terms of risk factors of youth consumption. Timeline for the workgroup has been established. The Michigan Department of Licensing and Regulatory Affairs (LARA) will be added in terms of regulations and compliance. Marijuana inspection of retailers to determine if they are selling to youth. Data is available from Washington State and Colorado. Adverse events on edibles have been observed. Please share thoughts on data needs. Joel shares some indicator data, such as State EPI Profile, MIFI, Monitoring the future Survey, and the YRBS, as additional indicators for Su Min to work with. Questions were addressed.

Marijuana fact sheet

Su Min presented an updated fact sheet to the group; marijuana perceived risk and abuse from *Monitoring the Future* (12th grade) over the last 12 years reduced from 50.8% in 2007 to 26.7% in 2018, from a national perspective. She also explained the bar graph on behavior and explained the 30-day use compared between 2007 and 2017 and stated the percentages.

Prescription Drugs

- Su Min moved her portion of this topic to Overdose Deaths portion of this meeting.
- Jane Gorge regarding Adrian Waller, an epidemiologist from Washtenaw County who conducted a special edition relating to 48 conversations with front line staff called the Healing Forest that promotes the concept of recovery-oriented Systems of Care (ROSC). Will forward to everyone in this group.

> Heroin

• Joel talked about morbidity and mortality weekly report and asked the group to review.

Legalizing Marijuana

• Larry said Lisa attended the Michigan Model and revising it of which he explained where it is in the process. We have asked them to revise their curriculum. Information about marijuana to be added to their curriculum, as well as online for a fee thru the Department of Education and Human Services; Population Health.

> E-Cigarettes

House Bill 4017 introduced by Representative Sue Allor from Wolverine to look at e-cigarettes and treat like the
youth tobacco act and become a misdemeanor with penalties. Data was also presented from a Monitoring the
Future survey. Larry also mentioned statistics on FDA compliance checks comparatively.

> Alcohol

- MCRUD Conference April 23, 2019. Patrick's program will be presenting also.
- The Centers for Disease Control (CDC) will also be conducting a site visit. Will be setting up meetings with collaborative partners, so look for an e-mail from Patrick.
- Representative Dingell will be proposing a bill to put ignition locks in all vehicles.
- Looking to propose a federal bill where a 17-year old can serve alcohol in restaurants. Will be keeping a close eye on this.
- Further discussion took place regarding alcohol and its associated risks

Gambling

- Larry mentioned sports, electronic gambling, among others as areas that must be monitored closely.
- Su Min will share more data information as it becomes available.

2017 Overdose Deaths in Michigan – Su Min Oh

- Key findings were presented on draft document regarding the 2017 Overdose Deaths in Michigan, results included:
 - ✓ Age adjusted rate 2017 was significantly higher than 2016 at almost 28 people per 100K people.
 - ✓ Gender was higher for males than females.
 - ✓ American Indians overdose death rate was higher.
 - ✓ Summary in which all the percentages and tables were explained.
- CDC MMWR article published in December and January comparing 2016 and 2017 overdose deaths.

- Comments included: Match data with county, law enforcement in relation to zip code, mortality response, among others.
