#### **OROSC Updates – Angie Smith-Butterwick**

- **State Targeted Response (STR) to the Opioid Crisis Grant** – Explained the STR grant for the benefit of the new participants in this group. In the process of submitting a no cost extension application for one additional year; applying for the maximum. Also received follow-up interview requests from the Associated Press about our annual reports. Introduced Alicia Goodman as a new staff to the STR grant.
- **State Opioid Response (SOR) Grant** – Explained the SOR grant for the benefit of the new participants in this group. Prevention trainings are being scheduled. If you are an SOR grantee, please apply or if you are not an SOR grantee, let us know and we will search for space availability. Mentioned projects to be trained in, such as Prime for Life, to name one. After the GPRA is approved, it will be required for the SOR grant. Introduced Kelsey Schell as a new staff to the SOR grant. Questions and answers took place. We will also apply for the SOR Two (2) which will start in June or July 2019 that will be for 12 months.

➤ **2017 Overdose Deaths in Michigan – *Su Min Oh***

- A PowerPoint is being presented and was sent to everyone prior to this meeting. Updated variables of the data were described. Based on 2,686 cases identified through overdose deaths, the drug overdose death rates in Michigan were explained by varying demographics, such as age, race/nationality, gender, among others. Also described was the various opioids and the death rate data associated with each was explained, among other information. Patrick is interested in data related to alcohol involved overdose deaths. Questions and thoughts were asked of the group. Joel mentioned some possible visual changes/enhancements to the data.
