OROSC Updates – Angie Smith-Butterwick for Larry Scott

- **State Opioid Response (SOR) Grant** – Received notification for the supplemental funding and the amount. Soon we will receive a notice of award that we will only have seven (7) days to complete a plan on return to them. Designated to us is 14.5 Million. Must follow the funding opportunity announcement for the SOR grant. Encouraged us to supplement what we have in the works to the extent possible.

- **Council of State and Territorial Epidemiologists (CSTE)** – Su Min applied for the CSTE grant to look at 18 data points related to mental health and substance abuse. Data must be reviewed in three months. Su Min will be working with vital records. The purpose is to see if the data can be collected and find data that might be missing. Su Min elaborated on the various types of data that will be collected and the possible sources.

- Su Min shared with everyone the final [Drug Overdose Deaths in Michigan, 2016-2017](#) document and encourages use. It is available on the OROSC website at www.michigan.gov/bhrecovery. Su Min also communicated to the group some of the details about the various data indicators, as well as asked for ideas.

- **Marijuana Use**

- Joel says we are planning a dashboard profile to monitor marijuana use over time and look at trends. We will also be promoting services and indicators. As a starting point, we may want to reference Colorado and Washington State as models. Suggestion to add suspensions and expulsion data related to marijuana use. Rich Isaacson says he will double check as to whether the DEA has captured certain drug data. Rich went on to explain what is taking place regarding marijuana and other drugs at the DEA, as well as the effects on the human body with certain opioids. A suggestion was made to include the financial aspects of marijuana use. Dawn will provide a fact sheet/information to Su Min on research she conducted regarding drug interactions; marijuana and prescription medication. Su Min will look further into the suggestions and bring answers to the next meeting.

- **E-Cigarettes**

- House Bill 4164 – Amends Youth Tobacco Act to include vapor products and alternative nicotine products not to be sold to anyone under the age of 18 in Michigan. Referred to regulatory reform on February 2, 2019 and March 19, 2019 referred to the committee judiciary. Also reported was more information about the bill, such as fines. Will keep everyone posted.

- **Alcohol**

- **Gambling Disorder**

- Alia informed everyone about the Gambling Symposium that took place in Novi on March 1, 2019. Just getting underway are contracts implemented with seven of the ten PIHPs in 2018 for them to employ gambling disorder prevention coordinators who will increase awareness of gambling disorders and improve access to treatment in their specific regions. This will determine gambling disorder prevalence in Michigan.

- **Office of Highway Safety Planning (OHSP)** – *Christy Sanborn - Tabled*

- **Bureau of Epidemiology and Population Health/Division of Communicable Disease/HAI, Infectious Diseases Update** – *Joe Coyle/Seth Eckel*

- **Hepatitis C** – Brandon reported on the First quarter reports for the Syringe Service Programs (SSPs); 167,087 syringes distributed across Michigan, 119,000 returned among 1,500-line served visits. He also reported on other information regarding qualitative data, meeting with city councils, among others.

- **Harm Reduction Summit** – Joe let everyone know that registration is closed for the Summit, which will take place April 2, 2019, as well as the registration counts. During the months of May, June, July, and August, they will be holding regional harm reduction meetings around the state. Some of these regional meetings will be held tentatively in the following areas: Muskegon, Kalamazoo, Saginaw, Gaylord, Livonia, Macomb, Newberry and are encouraging people to attend. The purpose of the meeting was explained. He also explained tools that would be used, as well as other information. A *Save the Date* will be sent out to all SEOW members. Further conversation took place regarding Newberry of which Seth said he would take the size issue with Newberry into consideration when finalizing these meetings.
- **Bureau of Health and Wellness/Division of Chronic Disease and Injury Control/Tobacco Section/Injury and Violence Prevention Unit** – *Desiree McLain/Stephanie Larocco*
 - **Data Driven Prevention Initiative for Prescription Drug Overdose**
Stephanie presented an update about the new opioid CDC grant; two major components consist of surveillance and prevention. Surveillance would inform prevention. Another draft is due on Monday and therefore creating a final draft by the end of the month.
- **Bureau of Epidemiology and Population Health/Division of Environmental Health/Environmental Surveillance Section** – *Tom Largo/Rita Seith for Gabrielle Stroh Steiner*
 - **Michigan Opioid Morbidity and Mortality Surveillance (MOMMS)**
Onboarded the last analyst and training is in process. More emergency departments and diagnostic data are getting involved. Michigan Opioid Morbidity and Mortality Surveillance, CDC Opioid Overdose Crisis Cooperative agreement program, and Prescription Drug Overdose grants will culminate into a combined Overdose Data to Action (ODTA) grant. A monthly statewide report is sent out monthly. Will send drug overdose information to Su Min Oh and Lisa Coleman and Su Min will send the configuration.
- **Council of State and Territorial Epidemiologists (CSTE) Overdose Surveillance Workshop Recap** – *Rita Seith*
Rita spoke on how herself and two other analysts went to Oklahoma for a CSTE workgroup where they came together with other states to create a statewide action plan. She also passed out an overview of the workgroup to everyone. Last week expanded emergency medical services was approved. Other forms of data would be police, among others. She spoke on what other things were learned from the workshop, as well as implementation plans. She also spoke on various data the other analysts will be working on. Joel spoke on the Central Data Repository (CDR) and its role on this subject, as well as the counties in Michigan. Su Min mentioned vital records as another data source.
- **Opioid: Surveys of Health Perceptions and Family Experiences** – *Liz Agius*
Liz spoke on disclaimer first. Next, she shared and presented a PowerPoint about the survey, which included; public perceptions on Facebook and questions and data related to the results. Questions were asked and answers were shared.
