Introductions, Welcome, and Approval of Agenda/Minutes – Joel Hoepfner

Update on Next Steps/Action Items from Previous Meeting – Joel Hoepfner

- Alcohol and Drug Related Traffic Crash Data – *Dianne Perukel* to provide updates accordingly
- Consideration and Connectivity of the Opioid Strategic Plan – *Chelsea Walker, Joe Coyle, and others* – provide updates over the next few months.
- Young Adult Survey Infographic on the CDR - *Brooke Rodriguez* - No specifics. Su Min says it is now available on the OROSC website at www.michigan.gov/bhrecovery. Latest data was added. Brooke said Ellen did some updates yesterday and the CDR is under the factsheet tab.

OROSC Updates – Angie Smith Butterwick for Larry Scott

- **State Opioid Response Grant Application** has been released and is due August 13, 2018. Review will begin this afternoon, as well as preparation. Funding formula is like the State Targeted Response Grant.
- **Partnership for Success (PFS) Carryover Request** received to expand coverage availability in a few regions.
- **Adolescent Continuation Grant** awarded for year two. OROSC's family and youth coordinator will be reaching out to local recovery community organizations to start the process of building a network for family, youth, and caregivers who are looking for treatment support, including learning how to access services.

Emerging Issues and Trends - *Su Min Oh/Patrick Hindman/Group*

Opioids and Prescription Drugs, Alcohol, Heroin, Marijuana, E-Cigarettes - *Su Min Oh/Group*

- **Legalizing Marijuana** – Dianne communicated to everyone that she attended a Cannabis Conference (CANACOM) at Cobo Hall, as well as the details related to the conference.
- **E-Cigarettes** – No legislative movement on any tobacco related bills.
- **Alcohol** – House Bill (HB) 6086 has been introduced to post Fetal Alcohol Spectrum Disorder signage in outlets that sell alcohol.
- **Conference:** Attended the *Council of State and Territorial Epidemiological (CSTE)* Conference along with Joe and Patrick. North Carolina has developed a Microsoft Excel template for county level reports that we would like to use here in Michigan. More information and observations were related by Joe, such as region specific, as well as how others are getting more real-time data. In New York City, someone from the health department visits the patient and offers treatment options. As soon as the presentations are available they will be sent to everyone in this group. The *CSTE* has several subcommittees related to substance use and one for overdose committee and would like for Michigan to be part of the overdose committee looking at methamphetamine overdose deaths study.
 - ✓ **Comments:** Rich also communicates that they are seeing a lot of cocaine mixed with fentanyl across the country. Su Min will bring the drug overdose death data related to methamphetamine and cocaine to the next meeting.

Partner Updates – *All*

- **Office of Highway Safety Planning (OHSP)** – *Dianne Perukel*
2017 traffic crash data has been released. The county reports are up and running, and action teams, such as the *Impaired Action Driving Team*. The marijuana crash facts data will be released soon. Nationally, the Governor's Highway Safety Association report found that marijuana and opioids are the most common drugs people are driving on. Website link will be shared with everyone.
- **Bureau of Epidemiology and Population Health/Division of Communicable Disease/HAI, Infectious Diseases Update** - *Joe Coyle*
Joe summarized his role for the benefit of the new SEOW members. He spoke on the latest outbreaks, related to substance abuse, including Hepatitis A outbreak, and Hepatitis C, which has been at epidemic proportions, as the risk of other blood borne pathogens, such as HIV and a whole host of bacterial infections, to name a few. Seeking to promote harm reduction capacity, which include local jurisdictions are authorizing local jurisdictions to operate needle exchange programs; identified 10-12. He also spoke on other activities taking place regarding programs about substance abuse, such as conducted readiness surveys to learn about Syringe Service Programs (SSPs) operating in jurisdictions, among others. Target is next fiscal year for opioid block grant funding to fund the process. Questions were asked and answered.
- **Bureau of Health and Wellness/Division of Chronic Disease and Injury Control/ Tobacco Section/Injury and Violence Prevention Unit** – *Chelsea Walker*
 - **Data Driven Prevention Initiative for Prescription Drug Overdose**
Hired a fourth team member and lost a team member, which we are currently in the process of hiring. Last Stakeholder meeting went well. Workgroup workplans are not required, until August Stakeholder meeting. Also shared with the Stakeholder group was an updated data infographic created using a program called *gmx*, which will be sent to everyone to obtain your feedback after Communications approves.

- **Bureau of Epidemiology and Population Health/Division of Environmental Health/Environmental Surveillance Section – Ashley Miller/Gabrielle Stroh Steiner**
 - **Michigan Opioid Morbidity and Mortality Surveillance**
Ashley mentioned an excel version of what North Carolina was doing. She also mentioned some issues with the Great Lakes county map mergers. Draft report will be shared for your feedback is received. Going to Green Bay who is working on a tri-state surveillance report related to opioids about Native Indians.
 - **Centers for Disease Control (CDC) Opioid Emergency Funding**
Learning about the details of the funding. More updates will be available by the next SEOW meeting.
- **SEOW Charter Review**

- **Neonatal Abstinence Syndrome (NAS) Factsheet**
Megan explained changes to the map on the updated factsheet, as well as feedback from the group. Questions were asked and suggested were addressed. Will be sent to Communications for approval.
