# Emerging Issues and Trends - Su Min Oh/Patrick Hindman/Alia Lucas/Group Opioids and Prescription Drugs, Alcohol, Heroin, Marijuana, E-Cigarettes – Su Min Oh/Group

- **Prescription Drugs** Tabled
- ➤ **Heroin** *Tabled*

- ➤ Marijuana Use *Lisa Coleman* The Marijuana Prevention Workgroup has completed the *Marijuana Strategic Plan* and it will be sent to Communications for approval.
- ➤ **Tobacco and E-Cigarettes** Bills heard June 16, 2020 in the Senate; bills 781 through 786; these bills include taxing on e-cigarettes, create licensure for retailers who sell e-cigarettes, prohibition on flavored tobacco, raise tobacco to age 21 as federal. Will keep everyone updated.
- ➤ **Alcohol** *Patrick Hindman* Cocktails to go and social drinking are moving quickly in the legislature. The bill to extend the hours of sales have made it back to the agenda in the legislature. Will keep everyone informed as actions takes place. Joel mentioned other groups working on these items also; Michigan Alcohol, Michigan Coalition to Reduce Underage Drinking (MCRUD), among others.

**Mobilization** - Continuing mobilization for drivers who get pulled over and in process for July mobilization. Awaiting permission to utilize funding to move forward with our drunk driving activity in which we plan to develop some educational pieces. Mention of Colorado's release of a multiyear study in which they worked with those in the industry to get educational material out to the public from the voice of the industry. **Covid-19** - Still working from home and planning for fiscal year 22.

- ✓ **Syringe Service Program (SSP)** Planning to expand SSP in Southeast and Central Michigan and two new programs in Out Wayne County. We are also looking for fund a program in Oakland and Shiawassee counties. Some of the funding will be used to updates to the Syringe utilization Platform. Plan to make it more user friendly and more useful data.
- Harm Reduction Summit Decided to move forward for the Harm Reduction Summit which will be virtual around August 2020. Brandon will update everyone as the summit gets closer. No questions.

- ➤ Michigan Overdose: Data to Action (MODA) Tom Largo
  - Covid-19 Gabrielle will be submitting an article to be published in public health reports. What it will be looking at is the impact Covid-19 has on drug overdose, measured by ED visits and EMS runs. There have been changes in drug overdose in Emergency departments. Also mentioned was some of the statistics related to this subject.
  - **Grant Update** Rita mentioned the status of their grants. She will send links to anyone interested. Dashboard mentors have been established. We will also be putting together some training videos. Joel encourages everyone to be aware of MODA activity and supports. Rita will send information to Su Min.

# **▶ Drug Poisoning Outbreak Response Plan** – Rita Seith

Presented document to the group entitled, *Identification of a Drug Poisoning Outbreak*. In this presentation she talked about the various types of drug outbreaks and resulting data related to this subject. Su Min will contact

the National Office of National Control Policy to obtain what drugs are currently popping up in our neighboring states. Joel asks about mini grants and an answer is provided. Other members mentioned the usefulness, such as prevention trends or where outbreaks are occurring. Additionally, someone mentions the need for historical trends and relationships, client side, such as when and where an incident happened and what took place, the need for educational materials to send out to partners, a surface level autopsy; such as how communities are affected, overdose fatality reviews, the need for information in rural areas that have low incidences, rapid non-fatal overdose information, and action steps to organizations. Rita will e-mail Su Min the questions, as well as requests anyone who has further ideas or suggestions to contact Su Min who will communicate them to Rita.
