#### **Update on Next Steps/Action Items from Previous Meeting – Joel Hoepfner**

- **Treatment Episode Data Set (TEDS) Data Report focus on Adolescents – Su Min Oh**  
Started working on adolescent TEDS admissions data for the period 10 years between fiscal year (FY) 2009 and FY 2018; latest available. During this treatment period, admissions for age group 16-21 has seen a reduction. Will share data as report becomes more finalized.

- **STR Updates and follow-up**  
Working on final report based on Annual Report which was submitted to the feds on May 31, 2019. Alicia described the contents of the final report, such as barriers, successes, and outcomes. Timeframe end of June 2019.
- **Vulnerability Assessment** – To be presented in the future.

**Opioids and Prescription Drugs, Alcohol, Heroin, Marijuana, E-Cigarettes** – *Su Min Oh/Group*

- **Prescription Drugs** – *Su Min Oh*  
The latest *Michigan Automated Prescription System (MAPS)* MAPS utilization report, changes 2018. Check out their latest report. Will send the direct link to the report to everyone.
- **Heroin** - *Tabled*
- **Marijuana Use**  
A MDHHS marijuana prevention workgroup has been created who [www.michigan.gov/marijuana](http://www.michigan.gov/marijuana). Working on a media campaign for ages 16-20.
- **E-Cigarettes**  
The governor changed The Youth Tobacco Act to now prohibit the sale of electronic nicotine and vaping devices to youth under the age of 18. In addition, Electronic Nicotine Delivery System (ENDS) products were not deemed a tobacco product. Also, under consideration are changes to the federal youth tobacco act from age 18 to 21. She also explained other changes that may take place to the youth tobacco act, as well as the federal level. More to come.
- **Alcohol** – *Patrick Hindman*  
No new information since the last report; bills are still waiting to be moved along. A recent brief is now posted on my website regarding the hours of sale, as well as other information. Will be posted on our website to share with everyone.

- **Office of Highway Safety Planning (OHSP)** – *Christy Sanborn - Tabled.*
- **Bureau of Epidemiology and Population Health/Division of Communicable Disease/HAI, Infectious Diseases Update** – *Brandon Hool for Joe Coyle/Seth Eckel*
  - **Media Campaign** - Our Media campaign is coming out within the next month, website will be up in the next several days.
  - **Vulnerability Assessment** - We have identified through the vulnerability assessment new areas to expand SSP; which include new contracts for 2020 mentioning the various health departments, such as

Western UP, Dickinson Iron, Delta-Menominee, Benzie Leelanau, Ionia, Calhoun County, RED Project to expand into Ingham and Muskegon Counties. Also looking at two community-based organizations; one in Jackson and Cope Network in Kalamazoo.

- **Hospitalization Data** - An analysis of hospitalization data from the Michigan Inpatient database from 2016, 2017, and 2018 related to infectious disease complications, such as skin and soft tissue and vascular infections (cellulitis, osteo myelitis; tetanus, including others) among persons who use drugs. Looking at rates in various counties, such as Kent, among others, which will be quantified. Questions and answers were shared.
- **Hepatitis Annual Report** - Our hepatitis annual report has also been released and is posted to our website. The report includes trends in HCV infections among young persons which correlates with various substance use data. Su Min will be e-mailing this link out:

➤ **Bureau of Health and Wellness/Division of Chronic Disease and Injury Control/Tobacco Section/Injury and Violence Prevention Unit – Desiree McLain**

- **Data Driven Prevention Initiative for Prevention Drug Overdose Grant**  
Desiree let everyone know about the DDPI grant risk and protective factors and health equity, as well as other information related to this grant.
- **Site Visits**  
Preparing documents for closing grant CDC conducted a site visit and from this site visit and a considerable amount of information was learned. Many site visits have taken place. Stakeholder meeting was last week. SBIRT training took place. Working closely with Surveillance. Working on a need's assessment of our partners in terms of risk and protective factor needs in planning for the new grant starting on September 1, 2019.
- **Key Informant Interviews – Rita Seith**  
The Surveillance section added by describing more information regarding key informant interviews. The interview plan is to be with PIHPs and health departments in the region. After the interviews are complete, a survey will be sent out to local health departments. Joel suggests utilizing the prevention provider networks within this process.

➤ **Bureau of Epidemiology and Population Health/Division of Environmental Health/Environmental Surveillance Section – Tom Largo/Rita Seith for Gabrielle Stroh Steiner**

- **Michigan Opioid-Involved Morbidity and Mortality Surveillance (MOMMS)**  
Tom welcomed Gabrielle. Three opioid grants will be ending by August 31, 2019; Michigan Opioid Morbidity and Mortality Surveillance System, PDO, Opioid Emergency Response Cooperative Agreement (Sunset and CDC had one new grant starting September 1, 2019). Improve toxicity testing with medical examiners of which contracts are in place. Tom explains the STORM (Swift Toxicology of Opioid Related Mortality) and the process of submitting samples and receiving results within 48 hours, among other information, such as the swift results that can be obtained from death certificates using this process. Seventy-five percent required by CDC and we are only at 25%; which means a lot of work needs to be completed within the next two months.
- **Council of State and Territorial Epidemiologists (CSTE)**  
Attended this conference and there were CSTE position statements that define certain health conditions, such as infectious diseases, non-fatal opioid overdoses, neonatal abstinence syndrome of which definitions have been finalized and will be available at the end of July on the CSTE website.

➤ **Older Adult and Substance Use Disorders** – *Lisa Coleman*

Lisa conducted a PowerPoint presentation of the older adult and substance use disorder program. During July 2018, JBS International, Inc. contracted through Substance Abuse and Mental Health Services Administration (SAMHSA) conducted a technical assistance (TA) training and among other states, Michigan was chosen to receive this TA. Also mentioned was the data and statistics related to this program; increase in opioid use and alcohol use disorder. Preparing to get ready for a needs assessment and capacity of which will assist in the preparation of a strategic plan. A workgroup has been formed which consists of MDHHS staff, local providers working with older adults, Aging Adult Services, MSU Extension, health departments, tribal councils, social workers, gerontologists, and MPCA, who have participated at some time throughout the process. More information was communicated to everyone about the strategic plan, as well as the overall program, such as risk and protective factors. Questions and answers were shared.

➤ **CSTE Indicators Updates** – *Su Min Oh*

Su Min presented an update on CSTE. Updates included recommendations for Michigan substance abuse indicator project, version three. Data from 2016 will be submitted. Indicator one through 10 is related to substance use, among other indicators. Indicators 11 through 18 regarding mental health. CSTE will review our data, and upon approval, it will be updated on their website. Waiting for CSTE's approval.
