OROSC Updates – Larry Scott

- **DHHS Opioid Strategic Plan** – This strategic plan is being created which will include six pillars which will include prevention, early intervention, Medication Assisted Treatment (MAT) expansion, harm reduction, and justice involvement. Now developing outcomes for each of these pillars. A first draft is planned for the end of August. Thanks to everyone in the group who participated and shared data.

- **Naloxone Distribution Day** – A *Naloxone Distribution Day* will be tentatively August 30, 2019 (per Su Min, an international overdose awareness day). Michigan specific is being planned, via a centralized location venue vetting process. Press conference is being planned. Pharmacies will be on board in the planning process.

Emerging Issues and Trends - Su Min Oh/Patrick Hindman/Alia Lucas/Group

Opioids and Prescription Drugs, Alcohol, Heroin, Marijuana, E-Cigarettes – Su Min Oh/Group

- **Prescription Drugs** – *Tabled*
- **Heroin** - *Tabled*
- **Marijuana Use**
 - **Marijuana Prevention Workgroup** - In the process of developing a media campaign for youth 14 to 20 or so. Met recently with our partner Prevention Network (PN) who have created a marijuana toolkit with specific information surrounding adult use, marijuana laws, and questions from local health departments as well as others. Michigan Higher Network has created one specifically for colleges and universities. The toolkit is in the approval process after which it will be placed on the MDHHS website. In the process of creating a strategic plan; more to come.
 - **Marijuana Summit** – This marijuana summit will be for two days; July 29 and 30, 2019, 8:30 am to 4:00 pm, as well as other information on this subject. Dr. Bertha Madras will be a speaker. Will send Su Min Oh.
- **E-Cigarettes**
 - **Youth Tobacco Act** - now includes vaping, and alternative nicotine products. Synar protocol will be changed to reflect this change. Also mentioned was the tobacco compliance check rates. The tobacco legislation regarding tobacco age to 21, which includes e-cigarettes is still being discussed and will affect the Synar protocol.
- **Alcohol** – *Patrick Hindman*
- **Gambling Disorder** – *Alia, no updates*
- **Older Adult** - data was shared. A follow-up meeting took place yesterday. A meeting will take place on alcohol.

Partner Updates – All

- **Office of Highway Safety Planning (OHSP)** – *Christy Sanborn*
 - **Michigan Impaired Driver Program Assessment** – A final report is available on our website, in which the link has been sent to everyone in this group. Statistics and data were shared regarding fatalities and drugs. There was a decline in which indicate a decline. More information about these statistics can be obtained on the Michigan Traffic Crash Facts website
 - **Drug Impaired Driver** – hosting a second Drug Recognition Expert Training Course in October 2019 for trained law enforcement officers.
 - **Annual Drive Sober Get Pulled Over Crackdown** – This event will be takes place August 14 – September 1, 2019, where law enforcement will monitor and crackdown on impaired drivers.
 - **FY 2020 Highway Safety Plan** - submitted to the National Highway Traffic Safety Administration (NHTSA) of which the results should be available in the next two weeks.
- **Bureau of Epidemiology and Population Health/Division of Communicable Disease/HAI, Infectious Diseases Update** – *Joe Coyle/Seth Eckel*
 - **Harm Reduction** – accolades were mentioned about harm reduction as being a part of the *MDHHS Opioid Strategic Plan*.
 - **International Overdose Prevention** – described a documentary called *Bevel Up* that deals with working with the substance use population by a team of nurses delivering compassionate healthcare and conducting a presentation here. The plan is to have her come here (Lansing) and do a presentation in August.
 - **Syringe Service Program (SSP) Expansion** – Eleven health departments were directly funded by our program, of which six are ready and have their doors open. Seeking other regional health departments to buy into this program. Attempting to create a fact sheet focusing on key points, such as from 2016-2018, hospitalizations resulting in deaths, all hospitalizations in 2018 resulted in 600 million dollars in healthcare costs, among other information. Quarter two aggregate data should be available by the time the next SEOW meeting takes place.
 - **The Journal of Infectious Diseases Special Call for Abstracts** – Focus: Infectious diseases associated with the opioid epidemic; we have submitted three abstracts.

- **Bureau of Health and Wellness/Division of Chronic Disease and Injury Control/Tobacco Section/Injury and Violence Prevention Unit – *Jan Fields***
 - **Data Driven Prevention Initiative for Prevention Drug Overdose Grant**
Currently, winding down the Surveillance Grant that ends next month. The primary focus was to improve local for both the surveillance systems and increase outreach to prescribers/subscribers. Spoke of pilot communities; Catholic Social Services, Macomb, and Marquette to improve their surveillance system and increase outreach, and onsite evaluations of the three communities are now taking place. More in-depth studies will be conducted. A new team is being formed for the new grant. Efforts from monitoring and evaluation are demonstrated on an infographic displayed to the group. Questions and answers were shared with the group.
- **Bureau of Epidemiology and Population Health/Division of Environmental Health/Environmental Surveillance Section –*Rita Seith for Tom Largo and Gabrielle Stroh Steiner***
 - **Michigan Opioid-Involved Morbidity and Mortality Surveillance (MOMMS)**
MOMMS is being wrapped up. No questions.
- **Michigan Syndromic Surveillance System – *Stephanie Larocco***
Reports were e-mailed to everyone, which was explained. Some of the information included in the report entails currently showing trends in overdosing overall and overtime, broken down by a number of variables. Looking at trends and overdoses in people that have an identified region and explained the data. Data will be added as it becomes available. Developing an overdose syndrome system; monitoring for spikes in overdoses. Access is allowed for those working directly with this project; preparedness regions, local health departments, Surveillance section, among others. Access can also be requested. Questions were asked about the report and shared with the group. Will be looking at how we can utilize the data points.
