##### OROSC Updates – *Angie Smith Butterwick for Larry Scott*

- **Opioid Town Hall Meetings** – These opioid town hall meetings will be taking place throughout Michigan and are open to the public and will take place through the end of September. The federal government authorized another 1.5 million grant to combat opioids. Expect a release in September 2020. - **Partnership for Success (PFS) Grant** – Lisa is working on a new PFS grant due on March 6, 2020.
- **State Opioid Response (SOR) Grant** – The SOR carryforward application has been submitted for 17.5 million dollars. Also explained was the purpose of the carryforward. A status report on the state of the SOR was communicated to the group. The new projects will include enhancing syringe service, expand treatment in the upper peninsula (UP), allocation of funding to the Naloxone portal (allow requesting of Naloxone), outreach to buprenorphine prescribers who are not prescribing, expand jailed-based communications, and emergency outpatient treatment, among others. Year one annual report will be published soon, as it is now in Communications awaiting approval. Questions were asked and shared with the group.
- **SOR Supplemental Grant** – Also explained was this grant, which is a 16-month 14.5-million-dollar grant that started June 1, 2019 to September 29, 2020. Nothing public yet. Purpose is to go forth with SOR projects, funding for an *opioid health home in region four, working with SSPs*.
- **State Targeted Response (STR) Grant** - Completed STR to the Opioid Crisis - Grant Year 2 Report May 1, 2018 to April 30, 2019, which will be placed on the [www.michigan.gov/bhrecovery](http://www.michigan.gov/bhrecovery) website soon, as it is now in Communications awaiting approval. Also explained is what is happening with amendments.

#### **Opioids and Prescription Drugs, Alcohol, Heroin, Marijuana, E-Cigarettes – *Su Min Oh/Group***

- **Michigan Epidemiological (EPI) Profile 2019** – Su Min communicated some areas of this report and changes that would take place before it will be published. Information about the 2017-2018 overdose deaths comparison showing a decrease and stabilization. Also working on a fact sheet.
- **Prescription Drugs** – *Tabled*

- **Marijuana Use** – *Lisa Coleman* - Communicated to the group that the *Marijuana Prevention Workgroup* is developing a media campaign, as well as various themes relative to teens. Also shared with the group was video clips of various campaigns.
- **Tobacco and E-Cigarettes** – The federal government changed the selling age of tobacco to 21. The Youth Tobacco Act must be changed. More information was discussed and communicated to the group regarding these subjects.

  - Lisa said a strategic plan has been created through JBS International for older adults with alcohol and opioid use issues.
  - Patrick said that two new commissioners want more of his involvement in the Liquor Control Commission. Questions were asked and shared.

  - **Syringe Service Program (SSP)** – *Brandon Hool*  
Last year's fiscal data is complete. The online syringe utilization platform is up and running with more real-time, descriptive, and consistent data. All programs have access to it. Summit is April 2, 2020 with a half day workshop the day before, and we are now offering emergency medical service (EMS) continuing education credits. It is open to whomever wants to come. Registration is limited to 300 registrants and is expected to go out by the end of this week.

➤ **Michigan Overdose: Data to Action (MODA) – MODA staff**

- **(Swift Toxicology of Opioid-Related Mortalities (STORM) Program** - Nina Bowser said the STORM program just added for new drugs, which include amphetamine, Methamphetamine, cocaine, and PCP.
- **Community-Based Prevention** - Stephanie said the on the prevention side currently working on an RFP to community-based prevention to be finalized next week for almost a million dollars to the community level to approximately fund up to ten awards. Monthly report is out. Expect April for notification.
- **Surveillance RFP** – On the surveillance RFP sent to four medical examiners, we will be funding Western, Sparrow, Saginaw, and Genesee meant to enhance their testing. In return, the plan is to come up with a suspected opioid overdose case definition that medical examiners across the state can use, to predict sensitivity, as well as more information relative to this subject. Questions were asked and shared.

**Michigan Substance Use Disorder Data Repository (MI-SUDDR) Analytics Report – Brooke Rodriguez**  
Brooke explained to everyone a revamping of the MI-SUDDR website based on comments and suggestions. Community profile is being worked on. Distributed among the group were two documents explaining what has taken place as far as utilization by various groups is concerned.
