- 2017 Provisional Data – *Su Min Oh*
A report on the 2017 Provisional Data was shared with the group:
 - ✓ Total overdose deaths regardless of the drug is about 28 per 100,000 population; deaths rate involving any opioid including opium, heroin, natural/semisynthetic, methadone, synthetic, and unspecified opioids is about 20 per 100,000.
 - ✓ Vital Records 2017 data will be ready soon.
 - ✓ Sent link of the opioid crisis in Michigan to all members.

OROSC Updates – Angie Smith-Butterwick for Larry Scott

- Notification of award for the State Opioid Response (SOR) Grant amount is increasing by to 27.9M
- Carryforward of the State Targeted Response (STR) Grant and the bill is still active in the federal legislature (increases STR an additional two years)
- Master Agreements for the SOR and then work on the STR Continuation
- More information will be available
- Federal Drug Administration (FDA) - new hires (inspectors) starting soon and three more to go. We are also hiring an inspection leader
- Training: SUD Conference is at Cobo Hall September 15, 16, and 17, 2019. More information to come.

Opioids and Prescription Drugs, Alcohol, Heroin, Marijuana, E-Cigarettes - *Su Min Oh/Group*

- **Michigan Opioid Laws –**
- **Prescription Drugs**
 - ✓ Dispensation of controlled substances are going down in Michigan, but illegal drug use has not been determined.
 - ✓ According to the Michigan Automated Prescription Service (MAPS), seeing decrease in controlled substance use; especially opioids.
 - ✓ Angie related information about one of the proposals from Dr. Neff of Medicaid for the SOR grant.
 - ✓ Patients are complaining because they cannot get any prescription drugs.
- **Heroin – N/A**
- **Legalizing Marijuana –** On the November 2018 ballot. Governor signed legislation to ban marijuana infused alcoholic drinks.
- **E-Cigarettes – N/A**
- **Cigarettes -** Successful tobacco retailer inspection compliance rate is the highest ever at 89.9%. Synar report will be out soon.
- **Alcohol –** No new information
- **LARA –** Public hearing is today
