SUMMARY OF KEY POINTS

Introductions, Welcome, and Approval of Agenda/Minutes – Joel Hoepfner

OROSC Updates – Larry Scott

- **Michigan Epidemiological (EPI) Profile 2019** – The EPI Profile 2019 (issued every two years) is currently being updated by Su Min Oh and Theodore (Teddy) McNeir (OROSC intern). This document is utilized by the field. We will be asking for SEOW input and recommendations. Marijuana section will be added.

- **Treatment Episode Data Set (TEDS)** – Looking into cause of death/mortality reported in TEDS at discharge. Based on our findings, other areas may or may not be investigated, such as harm reduction, to name one. A suggestion was also mentioned to look at criminal incidence data. Necessary approvals have also been received, such as legal affairs, and Institutional Review Board (IRB) to move forward; 42 CFR Part two, and the Health Insurance Portability and Accountability Act (HIPAA) compliance. A draft of memo for PIHPs should be ready by the next meeting.
- **Center for Medicare and Medicaid Services Grant** – This is a two year and 18-month grant. We will be conducting a rigorous treatment needs assessment of eligible Medicaid and Medicare recipients, assessing costs/rates that we reimburse programs at, accessibility to treatment, health disparities, and a deep dive into morbidity/mortality assessments. Success with this grant will make the State of Michigan eligible to receive a three-year grant. This grant will be the first of its kind for Michigan.
- **MDHHS Opioids Strategic Plan 2020/2021** – A section will be added on an Opioids Plan, which may roll out in November 2019. Many thanks to this group for your input.
- **Overdose Deaths** – Su Min says she is working with Vital Records to finalize overdose deaths in 2018 death certificate file; less than 3,000.

Emerging Issues and Trends - *Su Min Oh/Patrick Hindman/Alia Lucas/Group*

Opioids and Prescription Drugs, Alcohol, Heroin, Marijuana, E-Cigarettes – *Su Min Oh/Group*

- **Prescription Drugs** – *Tabled*

- **Marijuana Use**
 - **Marijuana Prevention Workgroup** – Completing the Marijuana Use prevention strategic plan draft surrounding/focusing on youth, young adults, and pregnant women.
 - **Marijuana Prevention Media Campaign** – Working with Communications to increase impactfulness. We have held several focus groups. Brogan, the marketing company is recruiting casting talent for filming around the beginning of November 2019.
- **E-Cigarettes**
 - Lisa Coleman said congress is considering increasing the selling age of tobacco to age 21, a bill to ban flavor vaping. In connection with our Tobacco Section, we will be conducting two Electronic Nicotine Delivery System (ENDS) trainings to take place soon. First one was held last Friday and the next one is tomorrow 10/17/19 and approximately 35 will be attending.
- **Alcohol** – *Patrick Hindman*
 - **Outlet Density Measures** - Traveled to Atlanta regarding join an alcohol density workgroup to develop indicators looking at outlet density measures that we hope will be adopted nationally; for instance numbers of outlets per square mile. Patrick also gave some statistics relating to the number of outlets in Michigan. The Centers for Disease Control and Prevention (CDC) will be writing an outlet density how-to-document. Be on the lookout for the indicators.
 - **Underage Drinking** – Lisa Coleman gave an update on partnering with Prevention Network on the updating of the Underage Drinking Strategic Plan and will be asking for this group's advice and feedback, as well as others.

Partner Updates – *All*

- **Office of Highway Safety Planning (OHSP)** – *Christy Sanborn*
 - **Michigan Traffic Crash Facts Website** – OHSP and the Criminal Justice Information System are working on revamping the website with certain filters/profiles/actions/queries will have been removed. Will inform everyone on changes moving forward.

- **Michigan Impaired Driver Action Plan** – Has been updated and we are encouraging everyone to look at the Michigan Impaired Driver Assessment to incorporate planned recommended activities. A report of Data and stats were shared on traffic drivers/crashes. These reports are ready for public use/distribution. These reports can also be extracted from this website (Michigan Traffic Crash Facts Website).
- **Click It or Ticket It** – This event will take place starting tomorrow 10/17/19 through 10/31/19. Also communicated to the group was a publication listing driving crash facts data.

➤ **Bureau of Epidemiology and Population Health/Division of Communicable Disease/HAI, Infectious Diseases Update** – *Joe Coyle/Seth Eckel/Brandon Hool*

- **International Overdose Prevention** – Caroline (featured in Bevel Up) came to Lansing and conducted a presentation on delivering compassionate and reducing stigma related to substance use.
- **The Journal of Infectious Diseases Special Call for Abstracts** – Two abstracts were selected:
 - 1) Characteristics of Pregnant Mothers Hepatitis Infected and the Risk of Transmission to their Newborns.
 - 2) Hospitalization Data: ICD Codes for Individuals with Substance Use Code for Injection Drug Use and Skin Infections Associated with Injected Drug Use Not HIV nor Hepatitis Associated. Working on a new one-page manuscript to highlight the data from this study to be presented at the next meeting.
- **Syringe Service Program (SSP)** – There are 13 programs running which is close to 40 sites across the state. There were 5,691 Naloxone kits were distributed to programs across the state: 534 overdose reversals reported which roughly represents one in 10 is being used to reverse overdose. A report on the number of tests conducted for HEP C, HIV, including others. Huge rise in syringe distribution. During the next year additional funding will be available to fund more programs, such as the following locations: Grand Rapids Red Project will run a site in Muskegon, under the Red Project Umbrella in Lansing, Ionia County Health Department, Benzie/Leelanau County Health Department, Overdose Prevention Program at Hope Network in Kalamazoo, Jackson County Health Department, Calhoun County, and every county in the Upper Peninsula (UP), among others. The last Harm Reduction training will be conducted in Houghton on Monday on 10/21/19.
- **Media Campaign** – The media campaign is up and running of which was explained its content, purpose and what it seeks to accomplish. To see the interactive map, go to www.michigan.gov/SSP.
- **Syringe Utilization Platform** – Will be a live web-based APP where syringe data can be reported in real time by programs. Also mentioned was the various data to be entered, such as the number of times NARCAN was used, among others.

- **Accidental Fatal Drug Poisoning Vulnerability Assessment** – *Seith Eckels/Adam Hart*
 - ✓ Seth and Adam presented a PowerPoint to everyone on screen via webinar. Some highlights of this presentation included;
A map of funded SSP programs throughout the state, challenges of implementing SSP in Southeast Michigan and the need in that region, as well as other information presented related to this topic. A considerable amount of discussion took place on this topic. Follow-up on SSP data after approval will be shared on our website. The presentation is attached.
