SUMMARY OF KEY POINTS

SEOW Meeting Introductions, Welcome, and Approval of Agenda/Minutes – Joel Hoepfner

OROSC Updates – Larry Scott

- **Policy Academy** – OROSC is working with other state partners to apply 2017 Policy Academy: Improving Outcomes for Pregnant and Postpartum Women with Opioid Use Disorders, and their Infants and Families. The state team will develop an action plan to address the multiple and complex needs of this population and will receive up to 6-months of technical assistance from the National Center on Substance Abuse and Child Welfare.

Emerging Issues and Trends

Opioids, Prescription Drugs, Heroin, Marijuana, E-Cigarettes - Su Min Oh/Group

- **Prescription Drugs** – OROSC was not awarded for Prescription Drug and Opioid Overdose-Related Death Project.
- **Heroin** – OROSC will be working with Vital Records and Health Statistics to prepare data submission to ONDCP Heroin Coordination Work Group.
- **Legalizing Marijuana** – PA281 (Medical Marijuana Facilities Licensing Act), PA282 (Medical Marijuana Tracking Act), PA283 were signed on September 21, 2016 and effect of December 20, 2016.
- **E-cigarettes** – No movement on any e-cigarette bills.

Partner Updates – All

Michigan State Police (MSP) – County Marijuana-involved crush profile is in the final stretch. Waiting to find out more about the roadside saliva test pilot programs.

Michigan Primary Care Association (MPCA) – Once MPCA has more concrete information on Uniform Data System, Joe T. will share with the SEOW.

MDHHS/Viral Hepatitis Surveillance and Prevention Unit – Joe C. is participating in Drug User Health Workgroup.

Injury and Violence Prevention – Tom suggested we may want to recruit membership from Univ. of Michigan Injury Center. Prescription Drug Overdose: Data Driven Prevention Initiative (PDO:DPPI) is in hiring staff phase.

Carfentanil overdoses reporting to Michigan Poison Control Center – Cynthia Aaron, MD

Carfentanil is driven from Fentanyl and has been around since 1970's. Mainly used for tranquilizer for large animals such as elephant and rhino. What we see currently is Carfentanil laced heroin, which has no quality control whatsoever. It surfaced in Florida and made way to Ohio and Kent county in Michigan earlier this year. The amount they found in Kent county was extremely small amount, there no commercial immunoassay tool for it. There were 19 speculated drug over dose deaths related to Carfentanil.

Carfentanil involving overdose patient show different symptoms than heroin overdose. They appear not breathing, requires 3-4 doses of Narcan. Some recommended guidelines for health care providers include increasing carrying Narcan, several doses of Narcan, no discharge at least in 6-8 hours or 12 hours. For those in law enforcement, wearing gloves and eye shield are strongly recommended for safety.

CSTE Behavioral Health Indicators – Tom Largo

Michigan along with MN, NC, NM, is working with CSTE on Behavioral Health Indicators pilot test.

The impetus of it was lack of standard surveillance approach of substance abuse and mental health.

There are 5 Alcohol, 5 Other Drugs, and 8 Mental Health indicators identified and defined.

Oversite for indicators will be done by Alcohol and Other Drugs (AOD) subcommittee of CSTE and Tom is the chair.

The full report of Recommended CSTE Surveillance Indicators for Substance Abuse and Mental Health will be shared.

SEOW Member Feedback Survey – Brooke prepared and provided summary of SEOW member feedback survey.
