OROSC Updates – Larry Scott

- ➤ Updates None
- ➤ Health Disparities Report being developed by the Michigan Public Health Institute (MPHI) on the rate of follow-up among various race and gender groups for substance use and mental health related issues. Will share the report with everyone when it is completed in December 2020. Quality of services between racial populations experiencing these disparities was astounding and alarming. A lot of work needs to be done on follow-up with populations affected health disparities; African American, Latinos, Native Indians who are not receiving quality services when compared with other populations. Joel commented that there will be a lot more workforce development training related to this issue. The data source was Hospitals that participated Study was commissioned by the Health Endowment Fund and one other. Medicaid population recipients were highly affected. Alarming to see in fine print.

Emerging Issues and Trends

Opioids & Prescription Drugs, Alcohol, Heroin, Marijuana, E-Cigarettes - Su Min Oh/Patrick Hindman/Alia Lucas/Group

- Prescription (Rx) Drugs
 - ✓ 2018 Michigan Behavioral Risk Factor Surveillance System (MiBRFSS) The previous CDC grant we decided to ask questions related to prescription drug use, so we used the exact wording module. 2018 was the first time, and questions and data results were shared. Other questions were shared, such as why they took the medication. Su Min informed everyone what this survey is designed to ask questions of those 18 years of age and older. A question was asked, and comment made about if people asked about another option of sold to someone else and what those answers would look like. Su Min responded to the comment.
 - ✓ **Xylazine Involved Overdose Deaths** Watch out for new drugs, such as this one which is not for human use and laced with Fentanyl. Please share this information with your communities
 - ✓ **Methamphetamine** Use Rita said there has been an increase in methamphetamine use and the associated fatalities. She shared that data with the group. She also spoke on the dangers of mixing methamphetamine with diazepanes.
- ➤ **Heroin** Su Min Oh Tabled/None
- ➤ Marijuana Use Lisa Coleman Tabled/None

 - ✓ Synar 342 retailers were checked for compliance. There was a 15.1 percent retailer violation rate of retailers who sold to minors. This is the first year we had youth ask for e-cigarettes. Covid-19 were also a factor in the results.

- ➤ House Bill 4213 passed the house to the Senate. No voting session this or next week. Possible in December. If no action, the bill will die December 31, 2020.
