Expand Capacity for the Health Care Response to COVID-19

(FY2020 Appropriation Act - Public Act 67 of 2020)

June 30, 2020

Sec. 251. The funds appropriated in part 1 for the coronavirus public health emergency – health care capacity shall be distributed to critical health care providers in this state, in amounts and by a method approved by the state budget director and the director of the department of health and human services, for expenditure by those providers to expand capacity for the health care response to the respiratory virus coronavirus-19 (COVID-19). The state budget office shall report to the senate and house appropriations committees, relevant senate and house appropriations subcommittees, and senate and house fiscal agencies no later than June 30, 2020 and September 30, 2020 on the types of activities supported with the funds, and the amount of funds expended to date.
