Personal Protection Equipment Grants

(Public Act 123 of 2020)

September 30, 2020

Sec. 405. (1) From the funds appropriated in part 1 for personal protection equipment grants, the department of health and human services shall create the personal protection equipment support and testing program to provide grants to the following priority providers:

- (a) Long-term care facilities.
- (b) Dialysis facilities.
- (c) Outpatient facilities collecting diagnostic respiratory specimens.
- (d) Dental facilities.
- (e) Other outpatient facilities.
- (f) Home health care.
- (g) Long-term acute care hospitals.
- (h) Emergency medical service providers.
- (i) Pharmacies.
- (j) Funeral directors and mortuary services.
- (k) Residential congregate facilities.
- (2) The personal protection equipment support and testing program shall include grants for personal protection equipment, COVID-19 testing, and COVID-19 testing equipment. The grants shall be applied for and disbursed in the most efficient form and manner determined by the department of health and human services.
- (3) The personal protection equipment support and testing program grants shall be available for personal protection equipment, COVID-19 testing, and COVID-19 testing equipment purchased on or after March 1, 2020 in response to COVID-19.
- (4) The department of health and human services shall provide a report to the senate and house appropriations committees, the senate and house fiscal agencies, and the state budget office that includes, at a minimum, the number of grant applications received, the number of grants awarded, and a listing of individual grantees by county. The report shall be provided not later than September 30, 2020.

PROGRAM DESIGN

This program is structured as a reimbursement for personal protective equipment purchases up to a cap set based on expected 90-day Personal Protection Equipment (PPE) costs for that type of facility and number of frontline workers. Awardees are issued an award letter specifying their approved award amount, and then must submit proof of PPE purchase and delivery up to that cap. Then they will receive reimbursement for those costs.

NUMBER OF GRANT APPLICATIONS RECEIVED

There were a total of 3,327 applications received. Of those, 806 were initially removed or disqualified for a variety of reasons, including being submitted after the deadline, being a duplicate application, failure to sign or agree to required terms, failure to fill in required field, or submitting an invalid Employer Identification Number. This resulted in a total of 2,521 applications considered.

NUMBER OF GRANTS AWARDED

Award letters were issued to 295 organizations which included 308 individual awards. This is due to some organizations having multiple eligible facility types, each of which received a separate grant award. The total awarded was equal to \$24,903,330. As awardees drop out of the program for failure to submit required documentation or further due diligence, a second round will be awarded. When this occurs, we will then issue awards totaling the full \$25,000,000.
