## 5-Year Strategic Plans for IT Services and Projects

(FY2019 Appropriation Act - Public Act 618 of 2018)

#### **April 30, 2019**

- **Sec. 468.** (1) Beginning February 1, 2019 and monthly thereafter, the department of health and human services shall report to the senate and house appropriation subcommittees on health and human services, the senate and house fiscal agencies, and the state budget office on all of the following:
- (a) Fiscal year-to-date information technology spending for the fiscal year ending September 30, 2019 by service and project and by line item appropriation.
- (b) Planned information technology spending for the remainder of the fiscal year ending September 30, 2019 by service and project and by line item appropriation.
- (c) Total fiscal year-to-date information technology spending and planned spending for the fiscal year ending September 30, 2019 by service and project and by line item appropriation.
- (2) As used in subsection (1), "project" means all of, but not limited to, the following major projects:
  - (a) Community health automated Medicaid processing system (CHAMPS).
  - (b) Bridges and MiBridges eligibility determination.
  - (c) Michigan statewide automated child welfare information system (MiSACWIS).
  - (d) Integrated service delivery.
- (3) By April 30, 2019, the department of health and human services, in coordination with the department of technology, management and budget, shall provide to the senate and house appropriation subcommittees on health and human services, the senate and house fiscal agencies, and the state budget office a 5-year strategic plan for information technology services and projects for the department of health and human services. The strategic plan shall identify any scheduled changes in the federal and state shares of costs related to information technology services and projects over the 5-year period.

## Objective

The objective of this document is to serve as a supplemental executive summary to the MDHHS 5 Year IT Roadmap. It provides a high-level overview of the MDHHS Large Systems and yearly objectives for each Integrated Service Area (ISA).

#### How to Use This Document

This document is divided into two sections. The first section lists the MDHHS Large Systems and provides an overview of the five-year direction for these systems. The second section is organized by Integrated Service Area (ISA). A general description of the MDHHS area each ISA supports is provided along with a narrative describing the major technology objectives for the next five years for each ISA.

This document includes general objectives by year for the next five years. The functional objectives established for each system can be found in the MDHHS 5 Year IT Roadmap. \*

#### MDHHS Large Systems

The five largest MDHHS systems are mature production systems which include:

#### Bridges

Bridges was implemented in 2008. It is the eligibility and enrollment system for the Administration for Children and Families (ACF), Centers of Medicare and Medicaid (CMS) and Food and Nutrition Service (FNS) programs. Over the years, Bridges has been extensively modified to meet Michigan business needs and changes required under the Affordable Care Act (ACA). Bridges is anticipated to be modernized in phases to provide future sustainability.

#### Micses

The Michigan Child Support Enforcement System (MiCSES) was originally implemented in the late 1990's. It is one of the most mature large systems MDHHS supports. The Child Support Program and its best practices have evolved considerably since the implementation of the system. The MiCSES system will undergo modernization to align the system to the evolved program needs.

#### **Misacwis**

The Michigan Statewide Automated Child Welfare Information System (MiSACWIS) is the newest of the large systems and was converted from Services Worker Support System (SWSS) in FY14. It provides the agency with the Child Welfare case management and information system. MiSACWIS is anticipated to be modernized to Comprehensive Child Welfare Information System (CCWIS) standards which will improve functionality and data sharing.

#### **CHAMPS**

The Community Health Automated Medicaid Processing System (CHAMPS), is the web-based MDHHS Medicaid claims processing system. CHAMPS will continue to be enhanced to support the other large systems being modernized along with the concept of Integrated Service Delivery.

#### DCH Data Warehouse

The Department of Community Health (DCH) Data Warehouse is the decision support and longitudinal data analysis tool for some areas of MDHHS. The DCH Data Warehouse will be modernized to span across multiple MDHHS program areas, support Integrated Service Delivery and implement an architecture that is sustainable into the future.

### Behavioral Health and Population Health (BPH) Integrated Service Area

The Behavioral Health and Population Health (BPH) Integrated Service Area (ISA) covers the programs and systems used to promote the health and well-being of, and provide services to, the people of Michigan. The 5 Year IT Roadmap includes systems used to support the following areas: Behavioral Health Program, Population Health Bureau of Health and Wellness, Population Health Bureau of Family Health Services, Population Health Bureau of EMS, Trauma, & Preparedness, Population Health Bureau of Epidemiology & Population Health, Population Health Bureau of Laboratories and Population Health Maintenance & Operations. Behavioral and Population Health (BPH) Integrated Service Area is primarily funded by grant and general fund.

The following activities are included in the 5 Year IT Roadmap for BPH:

- FY19: New systems are being implemented to support the tracking of environmental lead exposure in housing structures and the lead exposure abatement registry. Systems reaching their technological end of life will be evaluated for modernization, system replacement or consolidation into an existing system. Systems will be integrated with MDHHS/DTMB standard solutions for increased security and authentication (MILogin) along with improved person identification and matching capabilities (MPI). Birth Defects and Cancer Registries, Newborn Screening and PatientCare systems will be enhanced to use quality assurance testing and validation tools. Systems such as MCIR, MDSS, MSSS, MiWIC and OBRA will have new functionality enhancements implemented.
- FY20: New systems are being implemented to support HHS Certification and Enforcement, Summer EBT for Children Program and Vital Events Reporting and Birth Registry. The implementation and migration to a new Laboratory Information Management System (LIMS) will begin. Evaluation for modernization, replacement and consolidation of additional systems approaching their technological end of life continues. Electronic Death Record Subscriptions will be made available for use by any system within the Enterprise. Additional systems will continue to be integrated with MDHHS/DTMB standard solutions for increased security and person identification. Systems such as MCIR, MiCLPS, MDSS, MSSS and MiWIC will have new functionality enhancements implemented.
- FY21: A new Behavioral Health Case Management system is planned and implementation of the LIMS system will be completed. Evaluation for modernization, replacement and consolidation of additional systems approaching their technological end of life continues. MDHHS systems will begin integrating with the Electronic Death Record Subscription Service and will continue as needed in future years. Additional systems will continue to be integrated with MDHHS/DTMB standard solutions for increased security and person identification. MCIR will complete their known functionality enhancements.
- FY22: Evaluation for modernization, replacement and consolidation of additional systems approaching their technological end of life continues. Additional systems will continue to be integrated with MDHHS/DTMB standard solutions for increased security and person identification.
- FY23: Evaluation for modernization, replacement and consolidation of additional systems approaching their technological end of life continues. Additional systems will continue to be integrated with MDHHS/DTMB standard solutions for increased security and person identification.

### Child Support Integrated Service Area

The Child Support Integrated Service Area (ISA) includes the MiCSES system, its related Data Warehouse and the MiChildSupport system which is Michigan's customer facing web portal for Child Support services. The Child Support program goal is to ensure the stability and performance of the systems and infrastructure while adapting its systems to meet Federal and State regulation changes as well as seeking opportunities to improve efficiency for Child Support Professionals. It is anticipated that the Administration for Children and Families (ACF) will continue to participate at 66/34 ACF/ MDHHS match rate.

The following activities are included in the 5 Year IT Roadmap for Child Support:

- FY19: MiCSES will be updated to comply with Federal regulations. System reliability will increase using interface improvements with the Licensing and Regulatory Agency (LARA) and employers for income withholding. Tools will be implemented for county performance standards measurement and self-service reporting. Planning and pilot efforts will begin for data Analytics, MiCSES modernization of front-end screens and IT tools & processes optimization.
- FY20: Child Support will implement data governance by participating with the MDHHS Enterprise Information Management (EIM) Program. MiCSES will begin the process to integrate with the MDHHS/DTMB standard solutions for increased security and authentication (MILogin) along with improved person identification and matching capabilities (MPI). Implementation of Analytics, MiCSES modernization of front-end screens and IT tools & processes optimization will begin. MiCSES will align with modernized Department of Natural Resources and Bridges to improve system reliability.
- FY21: Implementation of data governance will continue with the Enterprise Information Management Program. Phase 2 of Analytics will be operationalized and modernization of front-end screens will be completed. MiCSES will complete the integration with the MDHHS/DTMB standard solutions for increased security and authentication and improved person identification and matching capabilities. Child Support will evaluate the use of additional MDHHS enterprise IT assets including ISD.
- FY22: Enhancements will be implemented based on analysis from operational Analytics. Electronic Death Record Subscription (EDRS) will be integrated. Execution of data governance will continue with the Enterprise Information Management Program.
- FY23: Execution of data governance will continue with the Enterprise Information Management Program and enhancements will be implemented based on analysis from operational Analytics.

### Child Welfare Integrated Service Area

The Child Welfare Integrated Service Area (ISA) is comprised of an array of services and systems designed to ensure that children are safe and that families have support to care for their children. The main system within the ISA is the MiSACWIS system which is a case management tool for child welfare in Michigan, including Children's Protective Services (CPS), Foster Care and Adoption cases. It is anticipated that the Administration for Children and Families (ACF) will fund CCWIS new functionality at a 50/50 ACF/MDHHS match rate. Non-CCWIS development needs to consider the eligibility ratio of the foster care children in care (penetration rate) to determine the ACF match rate. This rate is approximately 55%. This means ACF is contributing 55% of 50% and results in a match of approximately 27/73 ACF/MDHHS match rate.

CCWIS Maintenance and Operations costs must first be cost allocated across all impacted programs (i.e. Medicaid, TANF, etc.). The remaining amount identified for Title IV-E is then matched at a 50/50 ACS/MDHHS match rate. Non-CCWIS Maintenance and Operations costs must first be cost allocated across all impacted programs. The remaining amount identified for Title IV-E must then consider the eligibility ratio of the foster care children in care (penetration rate) to determine the ACF match rate.

Pending the findings of an outside consultant, the following activities were previously planned in the 5 Year IT Roadmap for Child Welfare:

- FY19: The Child Welfare systems will align with the new Comprehensive Child Welfare Information System (CCWIS) Federal regulations with the creation of an overall data quality plan. System modifications will be made in support of the Implementation, Sustainability and Exit Plan (ISEP). Processes and systems will be modified to remediate CPS audit findings. Work will continue with system updates in accordance with Federal and State Program requirements. Data quality will be improved in MiSACWIS by reducing and correcting duplicate data. The Mobile Investigator tool, Michigan Online Reporting System (MORS) and Supervisory Control Protocol (SCP) Portal will be implemented.
- FY20: The Child Welfare systems will align to CCWIS regulations with the implementation of the data quality plan. Effort will begin to modernize MiSACWIS in compliance with CCWIS. Other Child Welfare systems will be evaluated for inclusion into MiSACWIS as part of CCWIS. System modifications will be implemented in support of the ISEP. Processes and systems will be modified to remediate CPS audit findings and system updates will continue in accordance with Federal and State Program requirements. MiSACWIS will be integrated with MDHHS/DTMB standard solutions for improved person identification capabilities (MPI). Child Welfare systems will be updated to accommodate Bridges modernization impacts. Functionality and roles will be expanded in the Mobile Investigator tool and SCP Portal.
- FY21: CCWIS regulations will be aligned with the implementation of MiSACWIS modernization system changes. Other Child Welfare systems will be evaluated for inclusion into MiSACWIS as part of CCWIS. System modifications will be implemented in support of the ISEP. System updates will continue in accordance with Federal and State program requirements. Child Welfare system integrations will be updated to accommodate Bridges and MiCSES modernization. Functionality and roles will be expanded in the Mobile Investigator tool.

- FY22: CCWIS regulations will be aligned with the implementation of MiSACWIS modernization system changes and the biennial data quality review will be executed. Other Child Welfare systems will be evaluated for inclusion into MiSACWIS as part of CCWIS. System modifications will be implemented in support of the ISEP. System updates will continue in accordance with Federal and State program requirements. MiCSES modernization will continue and MiSACWIS will be integrated with the Electronic Death Record Subscription Service.
- FY23: CCWIS regulations will be aligned with the implementation of MiSACWIS modernization system changes and the compliance review will be completed. System modifications will be implemented in support of the ISEP. System updates will continue in accordance with Federal and State program requirements. MiSACWIS will be integrated with the Department of Education for the exchange of education data.

### Eligibility Integrated Service Area

The Eligibility Integrated Service Area (ISA) includes Bridges, the Eligibility and Enrollment System for the Centers of Medicare and Medicaid (CMS) and Food and Nutrition Service (FNS) programs, as well as the various Health and Human Services Eligibility and Enrollment systems that support Bridges and the Field Operations administration. It is anticipated the Centers for Medicare and Medicaid Services (CMS) will continue to participate at a 90/10 CMS/MDHHS match rate for new development and a 75/25 or 50/50 work type specific CMS/MDHHS match rate for Maintenance and Operations. The ability to use CMS funds for developing Medicaid functionality which can be shared with other programs ended last year.

The following activities are included in the 5 Year IT Roadmap for Eligibility:

- FY19: The Bridges environment will be modernized to improve the underlying technology. This will make future development more efficient. Eligibility systems supporting Bridges will be evaluated for inclusion into Bridges. Eligibility systems will be updated to include both HMP3 Time Limits and Medicaid Workforce Engagement. Updates will be made to the Universal Case Load functionality to better align it with Field Operations Administration requirements.
- FY20: The Bridges system will be updated with improved end user functionality. Systems identified in FY19 as overlapping with Bridges will begin the migration into Bridges. Additional eligibility systems supporting Bridges will be evaluated for inclusion into Bridges. Final Universal Case Load functionality will be implemented.
- FY21: The Bridges systems will be updated with functionality which allows business users to maintain functionality that was previously reserved for the technical team to modify. Systems identified in FY19 or FY20 as overlapping with Bridges will begin the migration into Bridges.
- FY22: The Bridges system will be moved into Maintenance and Operations mode. Supporting systems will be placed into Maintenance and Operations as well.
- FY23: The Bridges system will be moved into Maintenance and Operations mode. Supporting systems will be placed into Maintenance and Operations as well.

### Enterprise Integrated Service Area

The Enterprise Integrated Service Area (ISA) includes systems, projects and resources which are leveraged across the Department of Health and Human Services. Shared technologies such as MILogin, Master Person Index (MPI), ISD Portal, the Enterprise Service Buses and common security controls are administered within the Enterprise ISA. This ISA also enhances and maintains the systems which are not specifically supported within another ISA. It is anticipated the Centers for Medicare and Medicaid Services (CMS) will continue to participate at a 90/10 CMS/MDHHS match rate for new development and a 75/25 or 50/50 work type specific CMS/MDHHS match rate for Maintenance and Operations. The ability to use CMS funds for developing Medicaid functionality which can be shared with other programs ended last year.

The following activities are included in the 5 Year IT Roadmap for Enterprise:

- FY19: Planning will commence for the implementation of common security controls across MDHHS. The Enterprise Service Buses are further expanded to connect additional MDHHS systems together. Additional data sources are loaded into MPI to support person matching across disparate systems. Individual systems within the Enterprise ISA are evaluated for consolidation into other systems or shutdown if they are no longer required.
- FY20: Common security controls will be implemented across MDHHS. The Enterprise Service Buses are further expanded to connect additional MDHHS systems together. Additional data sources are loaded into MPI. Individual systems within the Enterprise ISA are evaluated for consolidation into other systems or shutdown if they are no longer required.
- FY21: Common security controls will be implemented across MDHHS. The Enterprise Service Buses are further expanded to connect additional MDHHS systems together. Additional data sources are loaded into MPI. Individual systems within the Enterprise ISA are evaluated for consolidation into other systems or shutdown if they are no longer required.

The Medicaid Integrated Service Area (ISA) includes Michigan's Community Health Automated Medicaid Processing System (CHAMPS) which supports Medicaid provider enrollment and maintenance, beneficiary healthcare eligibility and enrollment, payments and encounters. Additional Medicaid related applications support children, the aged, the disabled and the infirmed along with Medicaid fund management. It is anticipated the Centers for Medicare and Medicaid Services (CMS) will continue to participate at a 90/10 CMS/MDHHS match rate for new development and a 75/25 or 50/50 work type specific CMS/MDHHS match rate for Maintenance and Operations. The ability to use CMS funds for developing Medicaid functionality which can be shared with other programs ended last year.

The following activities are included in the 5 Year IT Roadmap for Medicaid:

- FY19: MDHHS will perform the annual Medicaid Information Technology Architecture (MITA) self-assessment and certification required by CMS. CHAMPS will implement enhancements such as improving system usability, Healthy Michigan Plan (HMP) Phase 2 and the new Medicare card (SSN removal). New enhancements related to Level of Care Passive Redeterminations and HMP3 Waiver will be started. CHAMPS will have a security assessment performed and be responsible for any remediation that is required. Supporting systems will be evaluated for inclusion into the CHAMPS system as well as continue in Maintenance and Operations.
- FY20: MDHHS will perform the annual MITA self-assessment and certification required by CMS. CHAMPS will implement enhancements such as Level of Care Passive Redeterminations, HMP3 Waiver, Electronic Visit Verification and changes to incorporate the Fair Labor Standards Act (FLSA). CHAMPS will be aligned with changes resulting from Bridges Modernization. The CHAMPS security assessment and remediation will continue. Additional supporting systems will be evaluated for inclusion into CHAMPS or other identified systems. Impacted supporting systems will be updated to accommodate HMP3 Waiver changes. Supporting systems will continue in Maintenance and Operations.
- FY21: MDHHS will perform the annual MITA self-assessment and certification required by CMS. CHAMPS will be aligned with changes resulting from Bridges Modernization. Additional supporting systems will be evaluated for inclusion into CHAMPS or other identified systems. Supporting systems will continue in Maintenance and Operations.
- FY22: MDHHS will perform the annual MITA self-assessment and certification required by CMS. CHAMPS will be aligned with changes resulting from Bridges Modernization. Additional supporting systems will be evaluated for inclusion into CHAMPS or other identified systems. Supporting systems will continue in Maintenance and Operations.
- FY23: MDHHS will perform the annual MITA self-assessment and certification required by CMS. The CHAMPS and supporting systems will continue in Maintenance and Operations mode.

### Integration Service Areas

Integration Service Areas (ISA) provide the organizational structure to support the successful delivery of projects within a program area. There are currently 6 ISAs which include:

- Behavioral and Population Health (BPH) This ISA includes the programs and systems used to promote the health and well-being of, and provide services to, the people of Michigan.
- Child Support This ISA includes projects and systems in support of the Child Support Program.
- Child Welfare This ISA is comprised of an array of services and systems designed to ensure that children are safe and that families have support to care for their children.
- Eligibility This ISA includes the various health and human services eligibility and enrollment systems.
- Enterprise This ISA includes systems, projects and resources which are leveraged across the Department of Health and Human Services and the State of Michigan.
- Medicaid This ISA includes systems, projects and resources which are leveraged across the Medicaid enterprise, including Beneficiary Management, Provider and Payment Management, Aging and Adult Services and Michigan Medicaid as a Service (MIMaaS).

Each system within MDHHS is assigned to one of the ISAs listed above. This allows for each system to have appropriate levels of project oversight and management to help ensure successful system delivery. The system assignments are as follows:
