## **Foster Care Annual Licensing Review Process**

(FY2019 Appropriation Act - Public Act 207 of 2018)

January 15, 2019

Sec. 532. The department, in collaboration with representatives of private child and family agencies, shall revise and improve the annual licensing review process and the annual contract compliance review process for child placing agencies and child caring institutions. The improvement goals shall be safety and care for children. Improvements to the review process shall be directed toward alleviating administrative burdens so that agency resources may be focused on children. The revision shall include identification of duplicative staff activities and information sought from child placing agencies and child caring institutions in the annual review process. The department shall report to the senate and house appropriations subcommittees on the department budget, the senate and house fiscal agencies and policy offices, and the state budget director on or before January 15 of the current fiscal year on the findings of the annual licensing review and include summaries of actions undertaken to revise, improve, and identify weaknesses in the current annual licensing process and annual contract compliance.



# **Foster Care Annual Licensing Review Process**

The attached Excel document contains a summary of violations cited during the annual review, which include renewal and interim visits. The violations are listed in five categories: statute, rules, the Implementation, Sustainability and Exit Plan (ISEP) and policy and contract violations. The information includes violations for eighty-one annual visits to contracted Child Placing Agencies (CPA) and eighty–seven visits to contracted Child Caring Institutions (CCI).

The consolidated monitoring tools were reviewed and modified during fiscal year 2018 and contain the rule language and hyperlinks to ISEP, MDHHS policy manuals and to the child placing agencies' and child caring institutions' contracts to ensure findings are consistent with written requirements. The review tools have been made available online for all child placing agencies and child caring institutions to utilize for self-review and to ensure transparency in the review process. The MDHHS' Division of Child Welfare Licensing continues to review processes surrounding current licensing and contract compliance to ensure necessary revisions are made in order to improve and streamline procedures.
