OROSC Updates

A. Overall Updates – Lisa Coleman

Ms. Coleman provided answers to a couple questions regarding the Marijuana Prevention Workgroup.

Synar Update

Ms. Coleman provided an update on the amended Michigan Youth Tobacco Act (YTA). It was signed in June, to add electronic nicotine delivery systems (ENDS) products. OROSC is working with the Tobacco Section to change the YTA language on retailer signs. A Conversation with Federal Project Officer for the Block Grant regarding Synar protocol. SAMHSA indicated that ENDS needs to be included in the protocol. Dr. Oh and Ms. Coleman are working on draft protocols to include ENDS products for Synar and update the Master Retailer List. ENDS will not be included in the current Coverage Study.

B. Gambling Disorder (GD) Prevention Program – Alia Lucas

C. Opioid State Targeted Response (STR) Grant – Foua Hang & Madison Shutes

Ms. Hang reminded members that the first quarterly report (August 15th) is no longer required. She indicated that the next monthly update will be August 30th. OROSC is still working on the annual final booklet, which will include information from grant years 1 and 2. Key prevention data for Year-1 and Year-2 (combined): 1,738 people were trained in evidence-based practices and 12,087 naloxone kits were distributed. Ms. Shutes informed the members that site visits will be conducted with the Wayne State Evaluation Team August through September.

D. State Opioid Response (SOR) Grant – Logan O’Neil

Ms. O’Neil provided an update on the SOR Grant. The SOR Grant site visits will be conducted August through October. An agenda will be sent approximately a week before each site visit.

E. State Epidemiology Outcomes Workgroup (SEOW) – Su Min Oh

Dr. Oh provided informed the members that the strategic plan is in the final stages and will be shared once approval is received. The data will be posted on OROSC’s website. Dr. Oh shared the final data results for Synar with the workgroup membership. Approval is pending for those results to be shared publicly. Questions were asked and answered regarding the strategic plan.

F. Older Adult Wellbeing Initiative – Lisa Coleman

Ms. Coleman provided an overview on the current activities for the Older Adult Wellbeing Initiative. They are currently working on developing logic models. There are two webinars scheduled. August 2nd 11:00 am – 1:00 pm and August 23rd 9:00 – 11:00 am. The last in-person meeting is on September 11th. The goal is to have the strategic plan finalized by the end of September 2019. Ms. Coleman will be giving a presentation with JBS International consultants at the National Prevention Network Conference in Chicago this month.

G. Marijuana Prevention Workgroup – Lisa Coleman

Ms. Coleman provided update on the workgroup’s activities. MDHHS Communications is working with Brogan & Associates to develop a media campaign for youth and young adults ages 14 to 20. Ms. Coleman and Dr. Oh are preparing to sit in on the focus group testing on August 13th and 14th. Once the media campaign is finalized, Ms. Coleman will share it with the TSC Prevention Workgroup and the PIHP regions. Ms. Coleman briefly discussed the toolkit that Ms. Harder and her intern developed for colleges and universities. Once that toolkit is finalized, it will be shared.

Collaborative Partner Updates

A. MDHHS/Children’s Services Administration (CSA) – Jessica Kincaid

Ms. Kincaid introduced herself to the workgroup. Ms. Kincaid informed the workgroup that CSA and OROSC partnered together last year to develop the Substance Use Disorder Family Support Program (SUDFSP). It is for high risk families who have had a Child Protective Services (CPS) investigation and were referred by the CPS worker. Wellspring Lutheran, a private agency, was given the contracts to provide the program’s in-home services for 90 days for eligible families with a parent(s) or caregiver(s) who have substance use issues. If needed, a 90-day extension can be given. As a result of the Comprehensive Opioid Abuse Program Grant, they are offering statewide training focused on trauma and addiction, through Dr. Stephanie Covington. Ms. Kincaid applied for a Regional Partnership Grant on July 31st. It is a 5-year grant. The grant would be used to pilot a Sobriety and Treatment Team Program (START) in Macomb County.

E. MDHHS/Mental Health Services to Children & Families – Meghan Schmelzer

Ms. Schmelzer provided background information on the Mental Health Services to Children and Families. They have consultants, who are therapists, and they focus on children at risk of getting kicked out of childcare facilities. Ms. Schmelzer indicated that these children often have trauma. She shared that a new database system that is being created. So, they will now be gathering data around the ACEs questions and if the family has any experience of substance use or misuse. Additionally, the consultants and their direct CMH supervisors will begin to connect with regional substance use prevention coordinators and schedule local partnership meetings, between August and December, to meet and create relationships.

Michigan Prevention Data System (MPDS) – Su Min Oh

Dr. Oh shared that MPDS Outcomes Group no longer meets because they accomplished their task to develop a survey. The first batch of data collected was due July 21st. Dr. Oh requested that if anyone has any data that has not been sent, send it to the mailbox. Ms. Coleman indicated that there was a previous conversation about adding an intervention name to the group field in MPDS. MPHI is currently looking at the cost that would be associated with adding a drop-down menu with a list of intervention names. Once Ms. Coleman gets the final list compiled, she will send it out to the prevention coordinators. Questions were asked and answered.

Partnership for Success (PES) 2015-2020 Update – Lisa Coleman and Brianna Sabol

- a. **Project Year-3 Evaluation Report:** Ms. Sabol gave a presentation on the Project Year-3 Evaluation Report, which is based on CSAP evaluation goals. Ms. Sabol went over the evaluation report with the workgroup. Questions were asked and answered.
- b. **SUDDR Update:** A lot of work has gone into rebuilding the entire site. All the data is set up and running. They are now working on visual appeal for the users. They are working on breaking down the MiPHY data into four sections and add a table of contents.
- c. **Completed Items:** The quarter 3 report was submitted into SPARS on July 31st. An email will be sent soon regarding National Prevention Week contest nominees and awards. Project Year-4 site visits have been completed.
- d. **Coming Soon:** Satisfaction surveys will be sent to PIHPs and funded communities on August 5th. The in-person Sustainability Training will be held August 12th in Lansing at Community Mental Health Association of Michigan. The two online courses will available until August 9th. Each community will be responsible for completing a sustainability plan and will be due at the end of November.

Prevention Network: Michigan Higher Education Network (MIHEN), Parenting Awareness Michigan (PAM), Michigan Coalition to Reduce Underage Drinking (MCRUD) – Ken Dail

Mr. Dail shared that Prevention Network is trying to develop some trainings for providers, volunteer groups and coalitions. There will be a two-day conference entitled Prevention Matters. It will be held in Shiawassee County later this month. They continue to provide Prevention Ethics trainings. Prevention Network will have a Mental Health First Aid trainer on staff by the end of the week. Next year, Prevention Network will be contracting with Mid-State Health Network.

He indicated that the first draft of the MCRUD strategic plan has been sent out to the planning committee for their feedback.

Mr. Dail informed the workgroup that Parenting Awareness Michigan Conference is scheduled for November 18, 2019 at the Kellogg Center. There has been some discussion about potential reforming and reconstituting the Upper Parenting Awareness Peninsula Steering Committee

Screening, Brief Intervention and Referral to Treatment (SBIRT) – Lisa Coleman

Ms. Coleman indicated that she does not have any updates on SBIRT.

Training and Technical Assistance (TA) – Lisa Coleman

- a. Great Lakes Prevention Technology Transfer Center; this organization is being funded by SAMHSA. They are offering sustainability trainings. There will be one held in Mt. Pleasant on September 25th. Another training will be offered on September 26th. Ms. Coleman sent out the information for these trainings with how to register.
- b. SUD and Co-occurring Disorders Conference is scheduled for September 16-17th and will be held in Detroit. There will be a pre-conference session held on Sunday, September 15th.

Substance Abuse Prevention Skills Training (SAPST) – Lisa Coleman

- a. There were two trainings recently held (June – Gaylord & July - Grand Rapids).
- b. Update on local activities: Region 5 has a new SAPT trainer; EDC has been offering trainings for “Train the Trainer.”

Innovative Prevention Practices

Mr. Malta shared that Joel Hoepfner will be coming to meet with the prevention coordinators in his region. The training session will be focused on action-oriented agendas.

Ms. Thomas shared the highlights of the Faith-Based Initiatives Conference, which was held on July 30th.

Ms. Shelafoe shared that they have coalitions in every county in the Upper Peninsula. The coalition coordinators created a walk/run/bike event, which will span from one end of the Upper Peninsula to the other, for Suicide Prevention Month. The 2-day event will be held in September.

Dr. Oh shared information on a documentary, “Bevel Up – Drugs, Users and Outreach Nursing.” The documentary was focuses on street-level harm reduction efforts done by street nurses in Vancouver, Canada.
