JN 77841A – Force Account is for traffic signal material supplied by the Road Commission for Oakland County (RCOC), Traffic Control Build-ups by the RCOC, and utility hook ups (by the utility company) for the traffic signal interconnect network. The cost effectiveness for this work is approved by the FHWA’s letter dated December 14, 2005.

JN 56254A – Force Account is for traffic signal material supplied by the Road Commission for Oakland County (RCOC), Traffic Control Build-ups by the RCOC, and utility hook ups (by the utility company) for the traffic signal interconnect network. The cost effectiveness for this work is approved by the FHWA’s letter dated December 14, 2005.

JN 83534A – Force Account is for the city of Bay City to perform work on their existing street lighting system. This work is cost effective for the local agency to perform per CFR 23 Section 635.205

JN 83005A – Force Account is for a consultant to do a timing study for \$266,405, and the remaining dollar amount is for the city of Grand Rapids to make field changes to their traffic signal system based on the results of the consultants work.

JN 87289A – Force Account is for the advanced purchase of street light fixtures for a construction project. The street lights were competitively bid per the posted requirements for a locally let project.

JN 88000A - Force Account line item used to pay for the operation of the Macomb County Traffic Operations Center, and not physical construction.

JN 88002A - Force Account line item used to pay for the operation of the Oakland County Traffic Operations Center, and not physical construction.

JN 53782A – Force Account used to establish an “Intelligent Transportation System” ITS improvement to the area for the “South East Michigan Snow and Ice Management” (SEMSIM) project. The work involves various engineering studies on how to best apply the ITS solutions, and the implementation of the concepts developed.

JN 54989A – Force Account used to design and implement an ITS network in Wayne County (Project title is RIMS). All work orders authorized are also approved by FHWA.

JN 58099A – Force Account used to design and implement an ITS network in Wayne County (Project title is RIMS Phase II). All work orders authorized are also approved by FHWA.

JN 83576A – Force Account is for the village of Fife Lake to perform work on their existing street lighting system. This work is cost effective for the local agency to perform per CFR 23 Section 635.205.

JN 55954A – Force Account is for utility work by the utility company on their facilities for a total of \$131,326, and the remaining amount is for the signal work by the Ingham County Road Commission for a total of \$94,000.
