**NON-DISCIPLINARY ORDER APPROVING THE CHANGE OF LIVE RACING
DATES**

Oil Capital Race Venture, Inc., d/b/a Mount Pleasant Meadows is a race meeting licensee operating under the authority of the Horse Racing Law of 1995¹ (Racing Act). Mt. Pleasant Meadows, having previously submitted an application for a 2011 mixed breed race meeting license, has requested a change to the live race dates.

The live race dates, as applied for, have been amended in a request to race on the following dates:

- Saturday, July 23, 2011 and Sunday, July 24, 2011
- Saturday, July 30, 2011 and Sunday, July 31, 2011
- Sunday, August 14, 2011
- Saturday, August 20, 2011 and Sunday, August 21, 2011
- Saturday, August 27, 2011 and Sunday, August 28, 2011
- Saturday, September 3, 2011, Sunday, September 4, 2011, and Monday, September 5, 2011
- Saturday, September 10, 2011 and Sunday, September 11, 2011
- Saturday, September 17, 2011 and Sunday, September 18, 2011
- Saturday, September 24, 2011 and Sunday, September 25, 2011
- Saturday, October 1, 2011 and Sunday, October 2, 2011
- Saturday, October 8, 2011 and Sunday, October 9, 2011
- Saturday, October 15, 2011 and Sunday, October 16, 2011
- Friday, October 21, 2011, Saturday, October 22, 2011 and Sunday, October 23, 2011
- Friday, October 28, 2011, Saturday, October 29, 2011, and Sunday, October 30, 2011

Horse racing is only authorized to the extent this it is conducted in accordance with the Racing Act.² There is broad discretion under the Racing Act to fully and effectively execute the licensing, enforcement, and regulation of horse racing, pari-mutuel wagering and simulcasting.³ The powers and duties include those specified in the Racing Act and those additional powers necessary and proper to implement and enforce this act and to regulate and maintain jurisdiction

over the conduct of each licensed race meeting within this state where horse races or pari-mutuel wagering on the results of horse races is permitted for a stake, purse, prize, share, or reward.⁴

The Great Lakes Quarter Horse Association and the Michigan Horsemen's Benevolent Protection Association, the Certified Horsemen's Organizations under contract with Oil Capital Race Venture, Inc., d/b/a Mount Pleasant Meadows, support the request for the change in live race dates.

IT IS ORDERED that Oil Capital Race Venture, Inc., d/b/a Mount Pleasant Meadows request for changes to the live racing dates for the 2011 mixed breed race meeting, as noted above, is granted with the exceptions of Saturday, July 23, 2011 and Saturday, July 30, 2011. No live racing can be conducted on those two days.
