The Board, at its discretion, may require Applicant to furnish additional information, or to complete and submit additional forms. In addition, the Board may require additional individuals and/or entities to submit disclosures based on information contained in this application or otherwise identified during the Board's investigation.

Applicant must prepare and attach a separate personal disclosure form (Attachment A) for each individual who is a principal contact person, registered agent, representative, corporate director, shareholder, LLC member, officer, and/or partner of Applicant, and/or who directly or indirectly holds a pecuniary interest of more than 15% in Applicant.

A \$1,000.00 license fee must be submitted with the application.

Be advised that if any circumstances change any time after the application is received by the MGCB Office of Executive Director, and therefore the application on file no longer presents the correct facts, the applicant must immediately submit an amended answer to the affected question(s). When doing so, the document must be titled "Amendment to Racetrack License Application", and reference the question number(s), effective date of change(s), and detail the change(s) from the information originally provided in Applicant's Racetrack License Application.
