# Continuing the Conversation: Regional Infrastructure Asset Management Summits

## Fall 2019 Summary Report

#### Background

The Michigan Infrastructure Council (MIC), in partnership with regions across the state, designed a two-part summit series aimed at improving coordination and collaboration across a diverse set of asset owners/managers including water, transportation, utilities, and telecommunications infrastructure. The series consisted of meetings in the spring and fall of 2019 and was funded through Integrated Asset Management grants provided by the Michigan Regional Prosperity Initiative.

### Logistics and Events

The fall summits, themed "Continuing the Conversation," emulated the fast-paced format of the successful spring summits. Within a span of 2.5 hours, participants received updates on statewide asset management efforts, identified future infrastructure projects through an interactive mapping activity, and provided valuable practitioner feedback on several MIC priorities.

Asset Management Plans are rolling out on a three-year cycle through the Water Asset Management Council (WAMC) and the Transportation Asset Management Council (TAMC). Michigan's largest infrastructure owners across drinking water, wastewater, and stormwater (approximately 850 total) and roads/bridges (123 total) will



engage with the councils to complete and submit these Plans. Summit participants had an opportunity to learn about the upcoming plan requirements and work with council leadership to address concerns.

MIC Project Portal in support of the "Dig Once" Strategy will encourage asset owners to enter upcoming construction projects to identify opportunities for coordination across various infrastructure. Collaborative projects result in significant costsavings and reduced citizen impact from roadclosures and redundant construction. Summit participants provided



valuable feedback on the demonstration version of the portal. MIC is working to incorporate practitioner terminology, data



gathering, and communication recommendations prior to the V.1 release in summer 2020. Support for the Project Portal was overwhelmingly positive with 99% of participants indicating a desire to use the portal and/or learn more about the portal once it is released.


Asset Management Readiness Assessment Scale affirms the five asset management competencies: People and Leadership, Data and Information, Planning and Decision-Making, Policy and Governance, and External Communication and Knowledge Sharing and allows users to rank their ability through "readiness levels." The Asset Management Readiness Assessment Scale will be released in January 2020 and will capture consistent, statewide metrics across all assets and communities. These metrics, in turn, will allow for the creation of target improvement goals and systematic reassessment.

#### Next Steps

As measured through participant surveys, there is strong support for continuing the Regional Asset Management Summits, with nearly every response indicating a desire to meet annually or semi-annually, based upon scheduling, budget, and training needs. Constraints to travel budgets and staff time were recognized, prompting appreciation for the statewide approach to the summit locations. Similarly, there was support for keeping the summits short and information focused (Chart 1) with technology education (e.g. MIC Project Portal) occurring through independent study and/or webinars (Chart 2).

MIC will continue to work with the Michigan Association of Regions (MAR), sub-councils WAMC and TAMC, and key partners around the state to pursue future summit opportunities and develop best practice asset management content.
