## Are you Ready?

Considerations need to be taken to ensure preparedness and response to receive, assess, stabilize and safely transfer children when the situation requires.

- Pediatrics (age 0-17) make up 73.7 million or 24% of the U.S. population. In Michigan, 21.8% or 2.2 million of the residents are children.
- There were more than 139 million Emergency Department (ED) visits in the United States in 2017. Approximately 27.8 million or 20% of those were children younger than 18 years old.

## Objectives:

1. Increase the existing levels of planning and capacity of pediatric preparedness for healthcare professionals.
2. Describe comprehensive pediatric preparedness and identify the value during an emergency incident.
3. Demonstrate a coordinated, regionalized, accountable system that provides immediate and appropriate care.
4. Identify existing gaps and challenges faced in pediatric psychological/behavioral health.
