

Subject: Public comment on Civil Rights Act compliance and the "Efficiency Gap"

I would like to propose an approach to ensuring compliance with the Civil Rights Act that approaches the problem in a different way than what the team has proposed in previous presentations (i.e., ensuing voting districts exist for protected minorities).

My proposed approach would use the "efficiency gap" (or possibly other similar metric of voting efficiency equity) to ensure that no protected racial or ethnic group is has a disproportionate fraction of its votes wasted. By "wasted," I mean the sum of two types of votes:

- · First, votes for a winning candidate beyond the number required to win the election
- · Second, votes for a losing candidate.

The typical approaches to jerrymandering of "packing and cracking" often end up maximizing the number of wasted votes for a particular type of group, such as a political party. In my approach, the efficiency gap for each protected racial and ethnic group would be used by the Commission to ensure that no group bears a greater disproportionate share of wasted votes.

My motivation is based on the long history of public policy enshrining racial segregation of metropolitan areas in an unconstitutional and illegal way. Throughout Michigan, federal, state, and local government deployed numerous policies to enforce and further racial segregation, including FHA requirements for including racial covenants in deeds of new houses (including in my home town of Ann Arbor), choosing highway alignments that displaced and dispersed residents of areas like Detroit's Black Bottom, and offering nonprofit status to organizations that exclusively served segregated areas.

My concern about creating "minority districts" in redistricting is that such districts do nothing to reduce this history of injustice. Politicians elected from segregated districts have little incentive to desegregate, whether urban, suburban, or rural. If voters and vote districts are homogenous and segregated, those politicians are likely to support their homogenous and segregated lifestyles. Substantial research shows that when a politician relies on a broader and more diverse electorate to gain or stay in power, they tend to forward policies that benefit the general public instead of particular groups. I refer to research by Elizabeth Gerber, Bruce Bueno de Mesquita, and Alastair Smith.

I provided written comments urging the Commission to use Efficiency Gap. I'm now suggesting that it is an important way to ensure that the future doesn't repeat the problems of the past.

My name is Phil Phelps and I'm a former member of the Michigan State Legislature. I'm just now watching the committee hearings/meetings videos online and am currently watching the March 11th video, so if someone has already made the suggestion that I am about to make please forgive me for not tuning in to the good work you are doing earlier.

Each State Rep and State Senator likely holds informational town halls in his/her district often. They are usually looking to share current information with their constituents and the work you are doing would make for a great presentation to the residents of their districts. Each member of the legislature likely has several quality venues that will host the legislator and your staff/members at no charge to you. Also, while I was a member of the legislature I worked with the House Business Office to make sure that they would cover the costs of translators and equipment costs to accommodate members of the Deaf,

DeafBlind and Hard of Hearing Community while doing official business as a State Legislator. An event like this would qualify.
