STATEMENT OF WORK

1.1 Key Deliverable One:

- (a) **Michigan Litigation Expertise.** The attorney, firm or other entity must demonstrate litigation experience and expertise to represent the Commission.
 - 1. Briefly describe a minimum of 3 cases argued before the Michigan Supreme Court, including, in particular, cases involving constitutional or public policy issues. For each case, please include:
 - i. The case caption.
 - ii. The principal legal issues presented in each matter handled by the attorney, law firm orentity and the party represented.
 - iii. The outcome of the case and whether an appeal was pursued.

Costantino v. City of Detroit, 950 N.W.2d 707 (Mich. 2020)

Principal Legal Issues: Whether the trial court properly denied the plaintiffs' request for an injunction requiring the Defendants to conduct an audit of the November 2020 election and whether the trial court properly denied the plaintiffs' request to prohibit the defendants from certifying the election results or continuing to count ballots.

Outcome: While representing the City of Detroit, Fink Bressack took the lead role in this litigation from the trial court through the Michigan Supreme Court. Fink Bressack handled this matter under extremely tight timelines given the urgency of these election-related matters. Defendants prevailed at each level, culminating in the Michigan Supreme Court denying the plaintiffs' application for leave to appeal. No appeal was pursued beyond the Michigan Supreme Court.

Gelman Scis., Inc. v. Fid. & Cas. Co. of New York, 456 Mich. 305, 572 N.W.2d 617 (1998)

Principal Legal Issues: Whether the Michigan Court of Appeals properly held that insurance coverage for pollution damage under "occurrence-type" comprehensive general liability insurance policies could be triggered only if contamination was discovered during the policy period, and not if it was discovered many years later. David Fink, on behalf of a Michigan manufacturer, argued to the Michigan Supreme Court that the Court of Appeals, in multiple rulings, reached the wrong conclusion and should be reversed.

Outcome: In a unanimous opinion, the Supreme Court ruled in favor of Mr. Fink's client, reversing decades of precedent. This case is a legal "unicorn," a rare decision in which the Michigan Supreme Court ruled in favor of policy holders against insurance companies in a coverage dispute. No appeal was pursued beyond the Michigan Supreme Court.

Principal Legal Issues: Whether the Michigan Supreme Court should grant the petitioners' petition for extraordinary writs and declaratory relief, in an original action filed in the Michigan Supreme Court. The petitioners brought a series of claims related to the conduct of the 2020 general election, including baseless allegations related to the counting of absentee ballots at the TCF Center in Detroit.

Outcome: Fink Bressack represented the City of Detroit as a proposed intervenor-respondent. The City filed a response to the Petition and refuted the unsupported allegations and incorrect statements of the law presented by the petitioners. The Supreme Court denied the Petition. No appeal was pursued beyond the Michigan Supreme Court.

King v. Whitmer, 505 F. Supp. 3d 720 (E.D. Mich. 2020)

Principal Legal Issues: Plaintiffs brought a series of claims of widespread voter irregularities and fraud in the processing and tabulation of votes and absentee ballots during the November 2020 Presidential election. Plaintiffs alleged violations of the Elections and Electors Clauses of the Constitution and the Equal Protection and Due Process Clauses of the Fourteenth Amendment. The Plaintiffs moved for a preliminary injunction requiring officials to decertify the election results.

Outcome: Fink Bressack represented the City of Detroit as an intervenor-defendant. Fink Bressack took a leading role in defeating the plaintiffs' request for a preliminary injunction and obtaining dismissal of the action. The Supreme Court of the United States denied plaintiffs' petition for writ of certiorari. An Opinion and Order was recently entered by the trial court, granting significant sanctions sought by Fink Bressack against all of plaintiffs' counsel (9 attorneys) for their "historic and profound abuse of the judicial process." *King v. Whitmer*, No. 20-13134, 2021 WL 3771875, at *1 (E.D. Mich. Aug. 25, 2021). Opposing counsel have publicly stated their intention to appeal the trial court's order of sanctions.

Davis v. Detroit Pub. Sch. Cmty. Dist., No. 17-CV-12100, 2017 WL 3129838 (E.D. Mich. July 24, 2017)

Principal Legal Issues: Plaintiffs Robert Davis and D. Etta Wilcoxon brought claims purportedly arising under the United States Constitution and the Constitution of the State of Michigan, along with multiple statutory claims against various governmental and non-governmental entities challenging taxpayer-funded financing of the Little Caesars Arena in the City of Detroit. Plaintiffs claimed that the funding mechanism violated their constitutional rights, because, they argued, the City of Detroit millage voters only consented to be taxed for school purposes. Among other legal

theories, the Plaintiffs argued that the pending litigation exception to Michigan's Freedom of Information Act is superseded by a right to public inspection of records set forth in the Michigan Constitution (a theory that had previously been rejected by the same federal judge in a prior lawsuit brought by Mr. Davis).

Outcome: Fink Bressack represented the Detroit Downtown Development Authority (DDA) and Brownfield Redevelopment Authority (BRA) as intervenor-defendants. Plaintiffs argued that the DDA and BRA intended to unlawfully use revenue generated from the school operating millage for a purpose other than the one that voters approved. The timing of this lawsuit was critical; if the claims were not quickly rejected, the Detroit Pistons would not have been able to obtain the necessary approvals from the National Basketball Association to move to the Little Caesars' Arena. The Court granted Fink Bressack's motion for summary judgment in its entirety on an expedited basis. An appeal was pursued, and the Sixth Circuit Court of Appeals Circuit affirmed. Davis v. Detroit Pub. Sch. Cmty. Dist., 899 F.3d 437, 438 (6th Cir. 2018). The Court also awarded Fink Bressack's clients sanctions against Plaintiffs' counsel.

Toth v. Callaghan, 995 F. Supp. 2d 774 (E.D. Mich. 2014)

Principal Legal Issues: Whether the manner by which the Michigan Legislature passed a certain law violated Article IV, § 24 of the Michigan Constitution (the so-called "title-object" provision).

Outcome: Fink Bressack represented the Regents of the University of Michigan as an intervenor-plaintiff challenging the enforceability of a statute, which had been passed by the Legislature and signed by the Governor. Fink Bressack challenged the constitutionality of the law, arguing that the enactment violate Michigan the Title-Object clause of the Constitution of the State of Michigan. The Court granted summary judgment in favor of Fink Bressack's client (the Regents of the University of Michigan). The ruling was not appealed.

Fink Bressack attorneys regularly handle significant complex litigation involving large volumes of electronic and paper documents. The firm works with large scale document production and document review on a daily basis. It is common for the firm to be involved in managing and reviewing millions of pages of documents in a single case. As such, Fink Bressack works with a variety of e-discovery tools and has established relationships with multiple vendors to assist with software solutions (including Michigan vendors).

As described in section 1.1(a) above, Fink Bressack has extensive experience litigating complex cases on behalf of government sector clients. In addition to the cases discussed above, Fink Bressack has handled many other matters on behalf of the City of Detroit, the Detroit Land Bank Authority, the County of Wayne, and the City of Madison Heights,

Fiore v. City of Detroit, No. 18-11565, 2018 WL 5014196 (E.D. Mich. Oct. 16, 2018)

Principal Legal Issues: Whether the City of Detroit violated the plaintiffs' equal protection rights when the City terminated a party's ability to bid for additional towing contracts with the City following the revelation of bribery involving the ex-husband of the owner of the plaintiff towing company. The plaintiffs sought a preliminary injunction for the immediate return of its bidding rights.

Outcome: Fink Bressack represented the City in federal court and defeated the plaintiffs' request for a preliminary injunction after an evidentiary hearing and extensive briefing. The plaintiffs ultimately dismissed their case.

B & G Towing, LLC v. City of Detroit, MI, 828 F. App'x 263 (6th Cir. 2020)

Principal Legal Issues: Whether the City of Detroit's use of information gleaned from an inadvertently disclosed wiretap affidavit to discontinue the City's business relationship with a towing company was a violation of Title III of the Omnibus Crime Control and Safe Streets Act of 1968.

Outcome: Fink Bressack represented the City in the District Court and in the Sixth Circuit Court of Appeals. The District Court granted the City's Motion to Dismiss, and the 6th Circuit affirmed.

City of Detroit v. Nationwide Recovery, Inc., No. 348814, 2021 WL 1051247 (Mich. Ct. App. Mar. 18, 2021)

Principal Legal Issues: Whether the defendant towing company's operations in the City of Detroit constituted a public nuisance that should be abated.

Outcome: Fink Bressack represented the City of Detroit at trial and on appeal in this publicnuisance action involving the towing of stolen vehicles. The City alleged that the defendant towing company was involved in promoting vehicle theft. Following a lengthy bench trial, the trial court found that the towing company's disputed practices constituted a public nuisance and that abatement by injunction was necessary. The Michigan Court of Appeals affirmed.

Direct Constr. Servs., LLC v. City of Detroit, Michigan, 820 F. App'x 417 (6th Cir. 2020)

Principal Legal Issues: Whether the Detroit Land Bank Authority and other governmental entities and employees violated a government contractor's due process rights when the contractor was barred from continued participation in a demolition program.

Outcome: Fink Bressack represented the Detroit Land Bank Authority in the District Court and the Sixth Circuit Court of Appeals. The Office of Inspector General of the City of Detroit had determined that the plaintiffs altered photographs of properties they demolished in breach of terms of their demolition contracts. The plaintiffs alleged they were suspended and later barred from further demolition work, and did not receive payment for completed work, on the basis of race. They also claimed the defendants retaliated against them because one of the plaintiffs claimed he refused to alter bid numbers for the demolition work and because he claimed he cooperated with the FBI during an investigation related to the Land Bank. The District Court granted the Land Bank's Motion to Dismiss, and the Sixth Circuit Court of Appeals affirmed.

- 2. Briefly describe any legal and advisory services provided specific to a client that is a public body, board or commission providing dates and references as appropriate.
- City of Detroit For over 40 years David Fink (and, since 2011, Fink Bressack) has provided legal and advisory services to the City of Detroit in many different matters involving a wide spectrum of issues including contractor disputes, environmental matters, election law, eminent domain and voluntary land acquisition, automobile No-Fault Act issues, potential challenges to the decennial census, towing regulation, regulation and franchising of cable operators, city income tax collection, whistleblower and wrongful discharge claims, allegations of police misconduct and countless other issues.
- County of Wayne Dating back to 1992, David Fink (and, in more recent years, Fink Bressack) has provided legal and advisory services, as well as litigation services as necessary, on matters related to Downtown Development Authorities, tax increment finance authorities, pension funding and board representation, Headlee Amendment challenges, environmental regulation (air quality and landfill regulations in particular), whistleblower and employment termination issues, and many other matters.
- Detroit Land Bank Authority Fink Bressack has provided legal and advisory services to the Detroit Land Bank Authority for the past 6 years.
- City of Madison Heights Fink Bressack provides legal and advisory services to the City of Madison Heights related to environmental matters primarily related to a former waste incinerator located within the City and owned by SOCRRA, a municipal corporation consisting of twelve municipalities.

In the course of Fink Bressack's representation of the City of Detroit, the County of Wayne and other public entities, issues related to FOIA and the Open Meetings Act often arise. The firm has frequently consulted with its clients regarding both issues. On multiple occasions the firm has also been involved in litigation in which Michigan FOIA and Michigan Open Meetings Act issues have been addressed.

The matter of *Davis v. Detroit Pub. Sch. Cmty. Dist.*, No. 17-CV-12100, 2017 WL 3129838 (E.D. Mich. July 24, 2017), described above in section 1.1(a)(2), is one example of litigation handled by Fink Bressack involving issues related to the Michigan Freedom of Information Act.

Boulevard & Trumbull Towing, Inc. v City of Detroit, et al, Wayne County Circuit Court Case No. 17-010371-CZ, is one example of a case litigated by Fink Bressack involving a claimed violation of the Michigan Open Meetings Act (OMA). In an Opinion dated April 25, 2019, the Court rejected the OMA claim and granted summary disposition to Defendants. The matter is currently on appeal to the Michigan Court of Appeals.

Principal Legal Issues: Whether the trial court properly denied the plaintiffs' request for an injunction requiring the Defendants to conduct an audit of the November 2020 election and whether the trial court properly denied the plaintiffs' request to prohibit the defendants from certifying the election results or continuing to count ballots.

Outcome: While representing the City of Detroit, Fink Bressack took the lead role in this litigation from the trial court through the Michigan Supreme Court. Fink Bressack handled this matter under extremely tight timelines given the urgency of these election-related matters. Defendants prevailed at each level, culminating in the Michigan Supreme Court denying the plaintiffs' application for leave to appeal. No appeal was pursued beyond the Michigan Supreme Court.

Johnson v. Sec'y of State, 506 Mich. 975, 951 N.W.2d 310 (2020) (NOTE: This case is also described above in Section 1.1(a))

Principal Legal Issues: Whether the Michigan Supreme Court should grant the petitioners' petition for extraordinary writs and declaratory relief, in an original action filed in the Michigan Supreme Court. The petitioners brought a series of claims related to the conduct of the 2020 general election, including baseless allegations related to the counting of absentee ballots at the TCF Center in Detroit.

Outcome: Fink Bressack represented the City of Detroit as a proposed intervenor-respondent. The City filed a response to the Petition and refuted the unsupported allegations and incorrect statements of the law presented by the petitioners. The Supreme Court denied the Petition. No appeal was pursued beyond the Michigan Supreme Court.
