METHODOLOGY

The Glengariff Group, Inc. conducted a Michigan statewide survey of voters. The 600 sample, live operator telephone survey was conducted on March 27-31, 2021 and has a margin of error of +/-4.0% with a 95% level of confidence. 50.0% of respondents were contacted via landline telephone. 50.0% of respondents were contacted via cell phone telephone. This survey was commissioned by the Michigan Independent Citizens' Redistricting Commission.

KEY FINDINGS

53% OF RESPONDENTS HAVE HEARD OF THE NEW REDISTRICING CHANGE

By a margin of 53%-46%, survey respondents have heard something about the 2018 constitutional amendment Michigan voters passed changing how redistricting is conducted.

There were not sharp partisan differences in knowledge, but there were substantial differences based on how engaged the respondent said they were in the political process. 62.6% of respondents who call themselves 'very engaged' have heard about the constitutional change.

There were also clear differences by education level. Respondents with a high school diploma were least likely to be aware of the change while those with a college degree were most likely to be aware of the change.

24.3% HAVE HEARD OF THE MICHIGAN INDEPENDENT CITIZENS' REDISTRICTING COMMISSION

24.3% of respondents have heard of the Michigan Independent Citizens' Redistrict Commission. 74.5% of respondent have not heard of the commission.

Voters that Lean Democratic were the most likely to have heard or the commission at 44.8%.

Among those respondents that say they are highly engaged in the political process, only 33.7% have heard of the commission while 66.3% have not heard anything.

There is again a direct link by education level with respondents with a college degree most likely to have heard of the commission.

Respondents who have heard of the commission were asked what they had heard about the commission.

- * 35.6% of those who had heard knew very general information like that the commission existed.
- * 13.0% knew that citizens would handle the redistricting process.
- * 11.6% said that the commission was looking for applicants.
- * 8.9% knew about the makeup of the committee.

By a margin of 89.0%-11.0%, respondents believe the work of the commission is important. A majority of Michigan voters believe the work of the commission is very important.

- * 54.1% of respondents said the work of the commission is VERY important.
- * 34.9% of respondents said the work of the commission is SOMEWHAT important.

There were statistically significant differences in the level of importance based on party affiliation with Democratic voters much more likely to find the work of the commission VERY important.

Voters over 40 were more likely to find the work of the commission very important than those voters who were under 40.

PLURALITY OF VOTERS HAVE NO OPINION OF COMMISSION

Respondents who had heard about the Commission were asked if they have a positive or a negative view of the Michigan Independent Citizens' Redistricting Commission.

- * 41.8% have a positive view.
- * 13.0% have a negative view.
- * But 43.2% said they had no opinion about the commission.

Respondents who had a positive opinion were asked why their opinion was positive:

- * 26.2% said gerrymandering needed to stop.
- * 19.7% said because the commission was made up of Democrats, Republicans and Independents.
- * 16.4% said because the commission takes politics out of the process.
- * 14.8% cited a fairer system.
- * 11.5% said change in the process was needed.

Those respondents who had a negative opinion were asked why their opinion was negative. Two themes dominated that small group of respondents:

- * 47.4% said the process was corrupt and would favor one party over the other.
- * 36.8% said there was no transparency and they did not trust it.

Among those voters most engaged in the political process, 41.8% have a positive view while 21.8% have a negative view. 32.7% have no opinion.

There were sharp differences by party affiliation with the small negative response coming strictly from the Republican respondents.

Among 'classic Republican' respondents, 44.4% view the commission positively while 33.3% view it negatively. 22.2% have no opinion. *But among 'Trump Republican' respondents, only 5.9% view the commission positively while 47.1% view it negatively.* 47.1% could offer no opinion.

The highest levels of 'negative perception' came from:

- * 62.5%. Voters that get their news from Newsmax
- * 50.0% Voters that get their news from Fox News
- * 47.1% 'Trump' Republican voters
- * 45.5% Strong Republican voters
- * 33.3% 'Classic' Republican voters
- * 31.6% Voters that get their news from Internet web sites
- * 27.3% Lean Republican voters
- * 21.8% Very Engaged voters
- * 21.2% 40-49 year old voters
- * 20.0% 50-64 year old voters
- * 18.1% Male voters

Voters were asked if based on what they know so far, the Michigan Independent Citizens' Redistricting Commission has been transparent. 75.3% of respondents said they did not know. 13.0% said they had been transparent while 8.2% said they had not been transparent.

Among voters that say they are highly engaged in the political process, 21.8% say the commission's work has been transparent while 16.4% said the work has not been transparent. 56.4% of those highly engaged in the political process did not know.

FIVE COMMISSION FACTS RATE HIGH WITH VOTERS

Respondents were read five different facts about the Michigan Independent Citizens' Redistricting Commission and asked to rank each fact on a one to ten scale based on how important that fact was to them. The higher the number, the more important the fact was to them. The five facts are ranked below based on their composite score rating highest to lowest.

The two strongest testing facts emphasized map fairness and public feedback.

- 8.4 The new maps will attempt to recognize communities of interest with shared cultural, historical or economic interests.

 But the maps will not be drawn to give an advantage to either political party, incumbent officeholders or any potential candidates.
- 8.4 The Michigan Independent Citizens' Redistricting Commission will hold at least ten public hearings throughout the state to inform the public about the redistricting process and solicit citizen input. And once the new maps are created, they will host at least five hearings around the state to get citizen feedback.
- 8.1 The members of the commission were selected through a random selection process to make sure every Michigan citizen had an opportunity to serve if they wanted.
- There are four citizens who affiliate with the Republican Party and four citizens who affiliate with the Democratic Party. But the largest block of commissioners are citizens that are Independent voters and not affiliated with either political party.
- 7.9 The commission will submit a new map for congressional and state legislative districts after the new census data has been made available. The new maps will be designed to keep county, city and township boundaries intact with districts that are reasonably compact.

The chart below looks at how each fact was rated by partisan affiliation. Democratic respondents rated all of the facts substantially higher than both Independent voters and Republican voters.

After being read all five facts, respondents were asked which ONE fact was personally most important to them. Two facts rose statistically higher than the other five facts:

28.0%	Commission will hold public hearings/ get public feedback
25.2%	Four GOP/ Four Dem/ Five Independents
19.2%	Recognize communities of interest
10.3%	Keep county, city and townships intact
10.3%	Commissioners randomly selected

Among those respondents who are very engaged in the political process, 24.5% cited the public feedback process and 23.3% cited the makeup of the commission.

Independent respondents chose 'recognizing communities of interest' as their second most important fact.

^{&#}x27;Sanders' Democrats chose keep boundaries intact as their most important fact.

'NEITHER PARTY GETS AN UNFAIR ADVANTAGE' RATES AT A NEARLY UNANIMOUS 9.2

Respondents were read four different goals of the redistricting commission and asked how important that goal was to them on a one to ten scale. The higher the number, the more important the goal is to the respondent. Below is a composite of the highest to lowest ranking goals. All four goals rank strongly. But rankings above 9.0 are rare – citing the importance of the simple goal that 'neither party gets an unfair advantage by gerrymandering districts.'

- 9.2 That neither party gets an unfair advantage by gerrymandering districts.
- 8.9 That citizens are in charge of designing districts, rather than politicians who would design districts to get themselves reelected.
- 8.7 That Michigan voters, not elected officials, have control of designing new congressional and legislative districts.
- 7.8 That communities with common historical, cultural and economic interests are put in districts together instead of divided to weaken their voice.
 - * Of critical note, nearly every demographic group rated the importance of 'neither party gets an unfair advantage' at a 9.0 or higher. *This goal unites all sides of the political spectrum*.
 - * The highest-ranking demographic groups for the 'communities of interest' goal was 'Sanders' Democrats at 9.1 and African American voters at 9.0.
 - * Other than the 'neither party gets an advantage' fact, 'Trump' Republicans were most motivated by the goal that citizens, not politicians, should design districts at 8.8.

Respondents with a high school education and those with some post high school education rated citizens, not politicians designing districts at 9.0 and 9.1. Those with a college degree were at 8.7.

NO UNFAIR ADVANTAGE, CITIZEN INPUT, TRANPARENCY RESONATE WITH VOTERS

Respondents were read three unique messaging statements and asked to rate them based on how important it was to them personally. All three statements scored at 9.3 or 9.4. It is unique for messaging to rate above a 9.0. All three of these messages are extremely persuasive and important to respondents.

- 9.4 The redistricting process should make sure that nobody gets an unfair advantage.
- 9.4 The redistricting process should be transparent allowing all citizens to see how decisions are being made and have a voice in those decisions.
- 9.3 The redistricting process should allow for citizen input.

There are only minor demographic differences between how individual groups of voters rated each of these three statements.

48.2% BELIEVE PARTICIPATION WILL HAVE AN IMPACT

Respondents were asked if their participation in the Michigan Independent Citizens' Redistricting Commission will or will not have an impact on the commission's work. 48.2% of respondents said their participation would have an impact while 31.2% said their participation would not have an impact. 20.7% of voters did not know.

The chart below compares these numbers by political philosophy. Belief that participation will make a difference rises based on a respondent's position on the political spectrum with left leaning voters having a stronger belief it would have an impact compared to right leaning voters much more skeptical about making an impact.

There is also an inverse relationship based on age with younger respondents much more optimistic than older respondents.

And those respondents most engaged in the political process believe their participation will have the greatest impact.

Some of the most interesting differences in the impact of personal participation came based on where the respondent got their main news. Those respondents who get their news from traditional main stream media sources are much more likely to believe their participation makes a difference. But Fox News, Newsmax and local tv news respondents were much more pessimistic about the impact of their participation.

Respondents who said their participation would not have an impact were asked why they believed that:

24.6% said they were just one person.

17.1% said they were not going to get involved.

12.8% said the commission would do whatever it wanted.

11.8% said they may read and watch, but they will not be engaged.

38.7% OF VOTERS WILL PAY VERY CLOSE ATTENTION TO PROCESS

38.7% of voters said they will be paying very close attention to the work of the Michigan Independent Citizens' Redistricting Commission. 51.7% of voters – a majority – said they would be paying 'some' attention. 8.3% said they would not pay too much attention or no attention at all.

- * Among voters that are highly engaged in the political process, 56.4% will be paying very close attention while 39.9% said they will pay some attention.
- * Among voters that are somewhat engaged in the political process, 33.0% will be paying very close attention while 58.5% said they will pay some attention.

While Democratic voters [Strong Democratic, Leaning Democratic, 'Sanders' Democrat, or 'Classic' Democrat] look very similar in the level of attention they will pay to the redistricting process, 'Classic' Republicans and 'Trump' Republicans look very different.

Among 'Classic' Republicans only 29.6% will pay very close attention while 58.3% will pay some attention. But among 'Trump' Republicans 40.0% will pay very close attention while 42.4% will pay some attention.

Among 'Strong' Republican voters only 27.0% will pay very close attention while 55.3% will pay some attention, But among 'Leaning' Republican voters 60.4% will pay very close attention while only 35.8% will pay sone attention.

Traditional 'establishment' Republicans will be paying far less attention than 'Trump' Republicans.

Respondents most likely to follow the process very closely based on their news source are:

NEWS STORIES AND WEBSITE MOST LIKELY AVENUES FOR ENGAGEMENT

Respondents were read five different avenues that citizens can be engaged in the redistricting process and asked if that was a way they might become engaged in the process.

84.2%	Reading and following news stories
79.2%	By accessing Michigan's redistricting website
50.7%	By sending questions or providing comments to the Commission
45.8%	By attending a public hearing held by the Commission.
41.3%	By watching meetings online

While large majorities were willing to follow news stories and perhaps visit the website, far few were willing to actually engaged WITH the process. The highest percentages of respondents that would be willing to attend a meeting were:

HOW TO REACH PEOPLE

Respondents were asked which would be the best way to provide them with information about the redistricting process.

26.0%	Email
21.8%	Through news stories
18.3%	On the commission website
7.8%	Text Messages
7.7%	On Facebook
18.3%	Said they did not want to receive information or did not know

For those respondents that were very engaged in the political process, 32.5% wanted information by email, 20.2% wanted information from the website, and 20.2% wanted information via news stories.

42.0% of 'Sanders' Democrats said they want information by email compared to only 16.5% of 'Trump' Republicans.

27.1% of 'Trump' Republicans want information from news stories while only 8.0% of 'Sanders' Democrats want new story information. 14.0% of 'Sanders' Democrats and 15.3% of 'Trump' Republicans want information by text message – by far the two highest demographics for text messages.

For those respondents who are classic Republicans, classic Democrats or Independents, they want a mix of news stories and email.

For those respondents over the age of 65, 40.2% want information through news stories compared to just 22.0% that want email information.

'DISTRICTS ARE FAIR', 'NO ONE GETS AN UNFAIR ADVANTAGE'

At the conclusion of the survey, respondents were asked in an open-ended question what the single most important change they expected from the Michigan Independent Citizens' Redistricting Committee. Two themes overwhelmed all the messages: Districts must be fair. And nobody should get an advantage.

26.5%	District are fair
18.0%	Nobody gets an advantage
9.2%	Citizens can be involved in the process
8.0%	Transparency/ Citizens can watch the work as it is done
4.7%	Communities of interest remain together
3.7%	Proper representation of people and districts
3.5%	Politicians are not part of the process

- * 29.9% of voters over 65 and 32.2% of voters between 50-64, said the most important change was that districts are fair. The highest percentages for fairness were voters 50-64, those not engaged in the process (36.0%), and 'classic' Republican voters at 33.9%.
- * The highest demographic that said nobody should get an unfair advantage were 'Sanders' Democrats at 28.0%, college degree educated voters at 27.2%, and voters 40-49 at 28.2%.
- * Those voters most interested in transparency were Independent voters at 16.8%.

- * At 15.7%, African American voters and Independent voters at 15.1% were the most likely to say citizen involvement was crucial.
- * At 8.2%, 'Trump' Republican voters were the most likely to say that no change would occur.
