Midland County is my community of interest.

Midland County is NOT an urban community. The city of Midland population is 42,000; not a large city by any measure. Our other designated city in Midland County is Coleman, population of 1,230, extremely small. Surrounding the perimeter of our cities is farmland and lots of it. And it is some of the best producing farmland in the state. Midland County boasts sustaining over 500 farms covering 88,000 acres. Most of these are family farms coverer multiple generations. I am blessed to be a member of one of these family farms, which includes three generations; ages 28-98. Through years of hard work and also legislative support when needed from local, state and national leadership, we have grown our farm significantly. The needs of our community are very different from those of big cities like Saginaw and Flint. It takes leadership that understand the very different needs of agricultural operations and their families to sustain this rich community asset.
