There is absolutely nothing wrong with accepting the reality that people characterized as "communities" are in themselves diverse. Voting as individuals is what voting is in a healthy democracy is. Let people find for themselves issue by issue who they share common interests and perspectives with. Do not set up and reinforce unhealthy competitive politics and disunity versus encouraging cooperation. Just draw an X over the state map and use an algorithm to create equally populated districts from the mid point of the X clockwise radiating out. Something so simple would restore failing faith in government as not being a fixed game. It would prompt eclectic candidacies from eclectic districts. Nothing is perfect but at least the short comings would be randomized by the simplicity. No one would know going in and in the future what the districts maybe and exploit them as easily as politically. 



Dear Commissioners,

It is my understanding that the Commission is seeking input from Michigan residents regarding redistricting and its impact on our communities. As a resident of Presque Isle County, which is located on the northeastern shore of the state's lower peninsula, I assure you this county is quite distinct from those of others in MI. In fact, there is not a single traffic light in PI County!

By choice, my husband and I live in the Presque Isle Township where there is more wildlife than people, more trees than buildings, more trails than roads. There are no streetlights, no sidewalks, no super-stores. In the winter, two places are open: the post office and the library.

Our rural County boasts of 3 historic lighthouses, 4 state parks, numerous State-forest campgrounds, the largest waterfall in the lower peninsula, many karst formations of underground rivers and sinkholes, the world's largest open-pit limestone quarry, and 72 miles of magnificent Lake Huron shoreline. Natural resources abound.

The sounds of frogs croaking, birds singing, squirrels chattering, and coyotes howling fill the air. Deer, raccoons, porcupines, possums, snakes (and an occasional skunk or bear) are free to roam our piece of paradise.


There have historically been tensions between our Detroit neighborhoods and the Grosse Pointes, and we need to build bridges and find more ways to cooperate. This is one way to do it.
