Today, I would like to bring to your attention the confusion that exists among the public concerning the map drawing process, in hopes that you can clarify the situation.

During the March 4 Commission meeting, EDS gave a presentation to the Commission in support of its bid for the map drawing contract. During their presentation, Mr. Fred Hejazi from Citigate GIS, a partner of EDS, demonstrated how they would draw the district maps if given the contract.

During his 20 minute demonstration, he described the process they use as follows:

- 1. Start with the current maps.
- 2. Adjust the current maps based on census population changes.
- 3. Do this by adding and subtracting precincts to the current maps.
- 4. Once the current map includes the appropriate number of people, add the Communities of Interest.

Since that time, several individual commissioners have stated that the Commission did not intend to start with the current maps.

Still, EDS spent 20 minutes demonstrating to the Commission their process of drawing the maps in which EDS clearly stated that they started with the current maps.

Given the confusion among the public and the importance of this issue, the League is requesting the Commission to clarify their intent.

Will the Commission instruct EDS to start with Communities of Interest and not the current maps?

Good Afternoon Commissioners!

Thank you for taking on this enormous task and thank you for being deeply thoughtful when making your decisions.

I was hoping to get some clarification on something brought up at this week's meeting and I wanted to throw in my two cents (for what it's worth;)

At the request of the Commission, Julianne Pastula researched and gathered information related to the Americans with Disabilities Act. There were questions related accessibility during upcoming public hearings.

I don't believe there was a formal decision on this, as the issue wasn't addressed by the other members of the commission this week. I would like to share a few of my thoughts on the matter. To be clear, this is NOT a criticism. I'm sure you have a good understanding of accessibility so forgive me if this feels redundant. I think it would be a great idea to clarify your thoughts with the public. I wasn't quite sure where you landed on this topic, so it would be wonderful to get a little more information so we can all be on the same page:)

I'd like to caution you against making any blanket decisions/statements when it comes to providing accommodations. I don't believe you have. Just something to keep in mind. As we know, people with disabilities are not "one size fits all" when it comes to what is needed for equal access.

An individual may need to have a seat reserved near a bathroom because of a physical/medical disability. A person with Autism may need to be allowed in early so they can adjust to the environment and reduce their anxiety before the meeting starts. If there are any pamphlets or handouts during the

meetings, a blind individual may need a copy in braille, etc., etc. There are a million scenarios that are impossible to predict because our privilege means we've never had to consider them. It would be an injustice to say, "Well, we could do such and such, but it's not 'required'". I think that could put you in a sticky situation. Accommodations are relative to the individual. When it comes to their disability, they are the experts. They know best what accommodations are needed to ensure they have equal access.

I would strongly encourage you to consider accommodations on a case by case basis and to avoid setting up one policy for all.

I have not yet checked your website for this specifically, but if you haven't already, I believe it's wise and necessary to provide a section where people can not only request accommodations, but find additional information related to the request. It would be great for persons with disabilities to have a better understanding of the process; how to request, if there is any documentation required to receive accommodations, the expected timeline for processing the request, who to contact if there is a dispute, etc. I don't know if you are considering a sub committee dedicated to reviewing accommodations or know someone who might fill that role. Many places do require documentation before a service is provided. It's common practice at Universities, places of employment, and community/state/federal agencies who provide services. With this documentation, you will be able to demonstrate the legitimacy of the request if accusations of preferential treatment are made.

Getting feedback from the disability community is so important during this process. State and federal decisions dictate the quality of their lives in ways most of us will never understand.

Again, I would like to thank all of you for the deep consideration that happens before decisions are made. I see it every week and it is so refreshing to witness people with different political leanings and backgrounds working together for a common goal.

Dear Commissioners

With regards to the prototype website I saw during the April 22 Commission meeting, you must test the website with people of a variety of ages and technical expertise.

My experience tells me that, despite the best of intentions, websites are designed in tech "bubbles" with many unexamined assumptions about the public's ability to interact effectively with the sites. Sometimes, barriers to broad public interaction are addressed virtually as an afterthought with surveys.

But those who have trouble interacting are often unwilling to complete surveys and simply leave the site.

Testing of a site by people who know nothing about the site or the issues is the only real way to get good, broad, truly fair, equitable and accessible websites. The site must be tested by a range of people, including those with disabilities, those whose first language is not English and people who are challenged by tech interaction because of lack of experience.

Thank you if you have been planning for this or have conducted tests.
