Cycle 8 Form Implementation Guidance

In response to provider input on program form implementation, the MDHHS MIHP Team will be posting all Cycle 8 forms to the website <u>www.michigan.gov/mihp</u> by April 10, 2020. These are the MDHHS approved versions valid for implementation on June 1, 2020 in alignment with beginning of Cycle 8.

Program forms have been revised to have a consistent implementation date and align with requirements for Cycle 8. Program training forms (MDHHS–5706, 5717, 5766, 5848) are the exception, please visit the website for effective dates.

The MDHHS MIHP Team has posted the MDHHS approved forms to assure that staff are familiar with the new forms to be implemented on June 1, 2020. All beneficiaries enrolled on or after June 1, 2020 must utilize all new forms and beneficiaries enrolled on or after June 1, 2020 must utilize the PVPNs from Cycle 8 for all visits after June 1, 2020.

These forms must not be utilized prior to June 1, 2020.
