

Michigan Tuition Grant

Fact Sheet for Academic Year 2018-19



Description

Provides need-based renewable scholarships for undergraduate students attending eligible private or independent degree-granting non-profit institutions.

Application

To apply for MTG, a student must file a Free Application for Federal Student Aid (FAFSA). To check the status of an application, the student can log into the MiSSG Student Portal at www.michigan.gov/missg.

MTG Application Deadline

The deadline for Academic Year 2018-19 is March 1, 2018.

Eligibility

To be eligible for award, a student must:

- File a FAFSA prior to the MTG application deadline.
- Demonstrate financial need.
- Be enrolled in at least six credit hours at a participating institution.
 - ◆ All participating institutions are listed on the last page of this Fact Sheet.
 - ◆ Cannot be enrolled in a course of study leading to a degree in theology, divinity, or religious education.
- Possess a high school diploma or its recognized equivalent.
- Be a Michigan resident since July 1 of the previous calendar year.
 - ◆ If a dependent student, parent must also be a Michigan resident since July 1 of the previous calendar year.
- Be a U.S. citizen, permanent resident, or approved refugee.
- Not be incarcerated.
- Be an undergraduate student.
- Not be in default on any Federal or State student loan.
- For renewal, meet institution's Satisfactory Academic Progress (SAP) policy.

Program Limits

Awards are restricted to tuition and mandatory fees and pay up to a maximum of \$2,400 for the academic year at participating institutions. It is the responsibility of the college financial aid office to coordinate all sources of aid for which a student may be eligible. Other gift aid may reduce or cancel this award.

Institutions are limited to receiving \$4.2 million of MTG payments per academic year and are responsible for identifying who of their eligible students may be awarded MTG.

Current and future awards are subject to available and approved funding.
