this is what i found in the methodology: The housing budget for a single adult is based on HUD's median rent for a one-bedroom apartment (rather than an efficiency apartment used in the Survival Budget) at the FMR of 50th percentile. For one adult with children, the budget is based on a two-bedroom apartment at the median rent. Housing for a family of four is based on the American Community Survey's median monthly owner costs for those with a mortgage (instead of rent for a two-bedroom apartment used in the Survival Budget). Real estate taxes are included in the taxes category (below) for households with a mortgage. Adjustments are made for variation within a metropolitan area through the American Community Survey's 5-year estimates of Median Gross Rent, as discussed in the Household Survival Budget.
