Michigan Public Service Commission 2018 Year End Summary Telecommunications Rights-of-Way Permits Public Act No. 48

Pursuant to Public Act No. 48 the Michigan Public Service Commission received notification of 160 permit applications during 2018. There were 124 new permits and 29 extensions to existing permits approved in 2018. Of the 153 permits approved in 2018, 68 were unilateral permits and 85 were bilateral permits. A total of 7 permits were denied in 2018.
