Michigan Public Service Commission 2019 Year End Summary Telecommunications Rights-of-Way Permits Public Act No. 48

Pursuant to Public Act No. 48 the Michigan Public Service Commission received notification of 216 permit applications during 2019. There were 182 new permits and 31 extensions to existing permits approved in 2019. Of the 213 permits approved in 2019, 104 were unilateral permits, 93 were bilateral permits, and 16 did not specify a permit type. A total of 3 permits were denied in 2019.
