








MEMD Process Review Update Agenda



After identifying a discrepancy in a 2016 and 2017 MEMD savings value, the MEMD Technical Subcommittee has taken several steps to improve the MEMD update process and minimize future discrepancies.

Identify

The MEMD Technical Subcommittee determined a *preliminary* rather than *final* Tier 3 Thermostat and Home Energy Report measure savings value was used in the final 2016 and 2017 MEMD, respectively. Commission Staff **identified a need to review and improve the existing MEMD update process** to minimize future discrepancies.

Define

The MEMD Technical Subcommittee discussed challenges with the MEMD update process and further defined opportunities for improvement, including (1) MEMD measure type definitions and requirements, (2) reviewing timeline, visibility and documentation of behavioral measures; and (3) communication practices.

Explore

The MEMD Technical Subcommittee identified a smaller focused group (or MEMD Process Review Team) to **explore best practices nationwide for Technical Reference Manual** (TRM) measure requirements and update processes, and to develop recommendations.

Action

The MEMD Process Review Team is in the process of **developing recommendations and revised MEMD processes for implementation in the 2019 MEMD update cycle**, focusing on three key areas definitions, process, and communication. The team will work with Commission Staff and Collaborative members to incorporate feedback.

Review

The MEMD Process Review Team will continue to work with Commission Staff and the MEMD Technical Subcommittee to **review and evaluate process improvements after the 2019 MEMD update cycle** and identify further process improvements (as needed).

The MEMD Process Review Team is working to review and provide recommendations in three key topic areas 1) definitions, 2) update process, and 3) communication.

RECOMMENDATION DEVELOPMENT AREAS OF FOCUS

DEFINITIONS UPDATE PROCESS COMMUNICATION

The team is currently developing draft definitions to inform the MEMD update process to provide greater clarity to stakeholders. Definitions will be further refined with feedback from Commission Staff and Collaborative members.

The team is currently updating the MEMD Update Process Flowchart and documentation to refine steps, clarify stakeholder roles and responsibilities, identify measure requirements, and address the compressed review timeline. The final draft is dependent on completion of definitions.
