Greetings Natural Gas Operators and Stakeholders,

In an order dated September 11, 2019, the Michigan Public Service Commission opened docket U-20632 and directed the MPSC Staff (Staff) to establish a collaborative group. The purpose of this group is to review and discuss whether natural gas curtailment procedures should be updated to prioritize natural gas use for residential heating over natural gas use for electric generation when appropriate during energy emergencies. Additionally, the Commission directed the Staff to file a report in this docket of the results of the collaborative no later than June 30, 2020.

You and your team are invited to participate in two preliminary meetings, hosted at the MPSC offices, to discuss the existing curtailment tariffs. These two meetings will be held back-to-back with the distribution Mutual Aid Agreements workgroup meetings (U-20631). Subsequent meetings will be scheduled at a later date, as needed.
