What is MALCTP?

Why Advanced Lighting Controls?

The Michigan Advanced Lighting Controls Training Program (MALCTP) is a statewide initiative aimed at increasing the use of lighting controls in commercial buildings. MALCTP will educate, train and certify licensed electrical contractors and state-certified electricians in the proper programming, testing, installation, commissioning and maintenance of advanced lighting control systems. Advanced lighting control systems typically include: dimmers, occupancy sensors, photo-sensors, relay modules, and communication-based control devices.

Through proper installation practices, advanced lighting controls have the potential to improve energy efficiency in commercial facilities across Michigan and help achieve significant energy savings.

What is MALCTP?

The Michigan Advanced Lighting Controls Training Program (MALCTP) is a 52-Hour comprehensive classroom and lab training course for licensed Electricians, Electrical Contractors & Specifiers specifically focused on advanced lighting controls. The program is brand neutral and encompasses a variety of types of technologies in the lighting controls sector.

MALCTP utilizes a curriculum developed by the California Advanced Lighting Controls Training Program (CALCTP) in collaboration with Utility, Manufacturing & Energy stakeholders in California. Initial curriculum development and training deployment for CALCTP was funded by \$5M Department of Labor grant through the American Recovery and Reinvestment Act.

The CALCTP collaboration includes: California Energy Commission, Pacific Gas & Electric (PG&E), Southern California Edison (SCE), San Diego Gas & Electric (SDG&E), Sacramento Municipal Utility District (SMUD), National Electrical Manufacturers Assoc. (NEMA), CA Lighting & Technology Center at UC Davis, CA Community College System and CA Labor-Management Collaborative of IBEW & NECA.

What is MALCTP in addition to Electrician Training?

To ensure proper commissioning and installation, the MALCTP program has developed a business component on how to effectively price an installation. Additionally, MALCTP partners are developing a course for specifiers (Architects, Engineers, and Lighting Designers) on advanced controls design and specification.
