“Adopt and issue minute dated August 7, 2007 amending the Commission’s June 12, 2007 minute approving tax credits under Section 8(14) of Public Act 48 of 2002, MCL 484.3108(14), the Metropolitan Extension Telecommunications Rights-of-Way Oversight Act. Subsequent to approval of that minute action, AT&T Michigan filed for an adjustment to its tax credit for an additional allowable tax credit of \$16,863.”
