Michigan Public Service Commission 2009 Year End Summary Telecommunications Rights-of-Way Permits Public Act No. 48

Pursuant to Public Act No. 48 the Michigan Public Service Commission received notification of 89 permit applications during 2009. There were 68 new permits and 18 extensions to existing permits approved in 2009. Of the 86 permits approved in 2009, 70 were unilateral permits, 9 were bilateral permits, and 7 did not specify a permit type. A total of 3 permits were denied in 2009.
